## RESOLUTION NO. 2007-768

## Adopted by the Sacramento City Council

October 23, 2007

## 1) APPROVING THE 2008 REGULAR MEETING SCHEDULE FOR CITY COUNCIL, REDEVELOPMENT AGENCY, HOUSING AUTHORITY AND FINANCING AUTHORITY; 2) DESIGNATING FOUR WEEKS WHEN REGULAR CITY COUNCIL MEETINGS NEED NOT BE HELD; AND 3) SCHEDULING SEVERAL MEETINGS TO BE HELD ON THURSDAYS

## BACKGROUND:

A. The Brown Act (§54954a) requires that legislative bodies, except for advisory bodies and standing committees, provide for the time and place for regular meetings by ordinance, resolution, or by-laws.
B. The City Charter, Section 31 allows for the City Council to hold regular meetings at such times and places as may be fixed by Resolution, except that the Council shall meet after 5:00 p.m. not less than one evening each week.
C. The City Charter, Section 31 allows for the designation of four weeks a year wherein regular City Council meetings need not be held.

## BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

Section 1. The afternoon (2:00 p.m.) and evening (6:00 p.m.) meetings on Tuesday, January 1, 2008 (first meeting following winter recess and holiday) are scheduled for Thursday, January 3, 2008.

Section 2. The afternoon (2:00 p.m.) and evening (6:00 p.m.) meetings on Tuesday, April 22, 2008 (Capitol to Capitol) are scheduled for Thursday, April 24, 2008;

Section 3. The weeks of June 30 through July 11, 2008 (summer recess) and December 22 through January 2, 2009 (winter recess) are designated as the four weeks in which regular City Council meetings need not be held.

Section 4. The afternoon (2:00 p.m.) and evening ( $6: 00 \mathrm{p} . \mathrm{m}$.$) meetings on Tuesday,$ June 3, 2008 are scheduled for Thursday, June 5 to allow for participation in Election Day activities

Section 5. The afternoon (2:00 p.m.) and evening (6:00 p.m.) meetings on Tuesday, August 8, 2008 meetings are scheduled for Thursday, August 10 to allow for participation in National Night Out activities.

Section 6. The afternoon ( $2: 00$ p.m.) and evening ( $6: 00$ p.m.) meetings on Tuesday, September 30, 2008 are scheduled for Thursday, October 2 to allow for participation in Rosh Hashanah.
Section 7. The afternoon (2:00 p.m.) and evening ( $6: 00 \mathrm{p} . \mathrm{m}$.$) meetings on Tuesday,$ November 4, 2008 meetings are scheduled for Thursday, November 6 to allow for participation in Election Day activities.
Section 8. The afternoon (2:00 p.m.) and the evening (6:00 p.m.) meetings on
Tuesday November 11, 2008 are scheduled for Thursday, November 13, in observance of Veterans Day.
