

I am excited about the prospect of serving on the Sacramento Housing and Redevelopment Commission. I have made the city my home for the last 25 years. With a graduate education in environmental and urban planning, I have always taken an interest in residential and commercial developmental issues in Sacramento. As a homeowner in East Sac, and a landlord in Midtown, I have watched with enthusiasm as the dynamics of the city have changed in regards to revitalization and infill projects. I believe the goal of any well-planned region includes the creation of livable communities for all sectors of the population. From my perspective, a livable community includes residential housing options, ideally, a mix of owners and renters in proximity to one another. It includes retail and employment opportunities nearby to facilitate a better jobs-housing balance and promote increased pedestrian activity. It includes recreation and green space and community-building gathering spots. Modern cities need to consider future development along transit corridors, increasing density in the urban core, in an effort to get people out of their cars. They also need to focus on revitalization, without unintentionally creating problems of gentrification. A livable community with numerous resources provides a sense of dignity regardless of economic station in life. As our city moves forward, it is important to ensure that those people and neighborhoods on the margins are not left behind and that funding is allocated accordingly. It is my hope that by serving on the Commission, I could help in a decision-making process that works to create a Sacramento that is vibrant and inclusive for all its citizens.

My Masters Degree is in Environmental Studies with an emphasis in Policy and Planning. I worked in the environmental consulting sector as both an Analyst and Senior Associate specializing in California Environmental Quality Act (CEQA) impact assessment. Projects I have worked on and/or managed include studies of sensitive community issues, large scale mixed-use developments, a amusement park expansion, and a hazardous waste recycling facility. I am relatively new to town, having moved just under a year ago, and have finally settled into the point where I am now looking to become more involved in the Sacramento community. Sacramento has the ability and potential to create real and positive impacts by investing in our neighborhoods and community, and I would love to be a part of that process. My experiences the past few years have led to my becoming a much more active citizen, culminating now in working in the public sector. Prior to my current position at the California Energy Commission, I worked in Oakland as a canvasser and field manager at a grassroots environmental organization, Clean Water Action. It was here that I truly developed my passion for community organizing and politics, though I had nurtured this feeling throughout my time in college. Through my daily discussions with actual residents, I learned to be less jaded--essentially, I realized that by actually engaging in the political process, one can work toward the change they wish to see. It was also at Clean Water Action that I honed a specific interest in environmental and social justice. During my time at UC Berkeley, I studied mathematics and environmental studies, but generally stayed on the technical science side rather than social science side. Canvassing all over the Bay Area put actual faces to the theoretical issues I had discussed in classes, and environmental justice became a passion of mine. Moreover, while I was in school, I was a research assistant at the university's Center for Community Innovation. Here, I assisted in graduate and faculty research on gentrification issues, and through interviews and fieldwork was able to hear about and see directly the experiences of those displaced in the Bay Area. I had always been aware of the housing crisis, especially in Berkeley, where the homeless population was so abundant and unavoidable. But with this research position, I learned just how inextricably linked affordable housing, social justice, and gentrification are, and how that intersection is perhaps the biggest problem facing residents in the Bay Area. Now, I have learned of the housing issues and wealth disparities in Sacramento as well--too often, not only here but everywhere, members of our community are left behind in the decision-making process. Sacramento must focus its community development investments to ensure economic opportunity for everyone.
