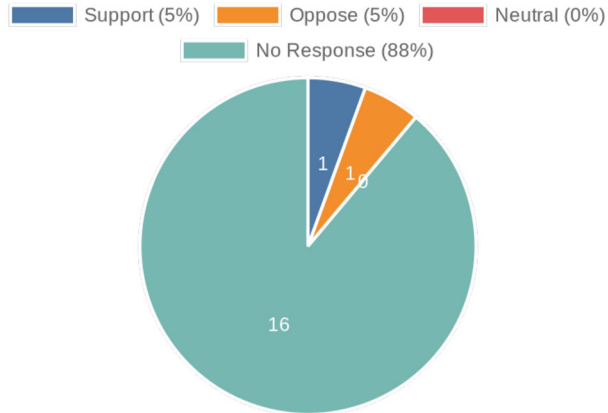

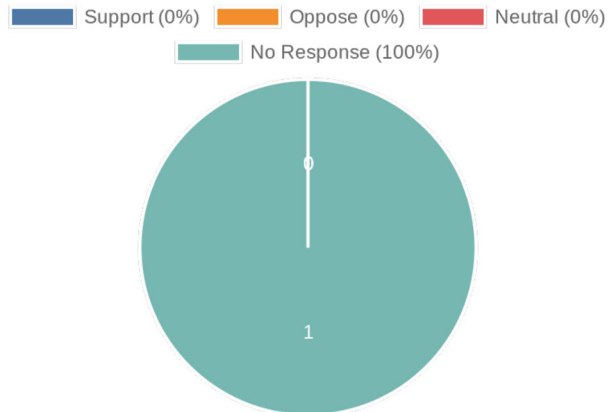

Dear Mayor McCarty and Councilmembers,

On behalf of the East Portal Bocce Club (EPBC), I am writing to express our strong support for the City staff's proposed lease. This lease will continue the long-standing partnership between EPBC and the City for the continued operation and maintenance of the East Portal Park Bocce Complex (Bocce Complex) in the "Little Italy" Historic District of East Sacramento.

Bocce is one of the few sports that can be played on an equal basis by people of all ages, genders and backgrounds, regardless of their physical abilities or disabilities. In addition to serving the immediate neighborhood and bocce regulars from throughout the city through league and recreational play, EPBC also provides court use and instruction for several youth, senior, veterans, and disability programs, including the City's Access Leisure program for persons with disabilities, a new VA teaching program for disabled veterans, and a "Senior Bocce Day" with the Eskaton Senior Retirement Community.

The East Portal Park Bocce Complex is widely considered one of the premier bocce venues in Northern California, regularly hosting tournaments with top players from throughout Northern California and Nevada who often stay in town, eating at local restaurants and shopping at local businesses to bolster our growing tourism economy. In 2022, Sacramento Magazine honored EPBC with the “Best of Sacramento” award for Best Bocce Ball Courts and Nextdoor.com acknowledged EPBC as a “Neighborhood Fave” for positively serving East Sacramento.

EPBC volunteers have expertly and continuously operated, maintained, and repaired the Bocce Complex, mostly without assistance from public funds or City Parks staff, since EPBC was formed in 1960. Perhaps nothing demonstrates the tremendous value of the partnership between EPBC and the City more than our response to the New Year's Eve 2022-23 storm that produced a lethal combination of high-velocity wind and rain, uprooting a large heritage City tree, destroying part of the pole barn roof covering two of the five bocce courts, and severely damaging the light system, fence, and court surfaces. Within days after the storm damage, EPBC members began working to make the courts playable again. EPBC contacted their insurance carrier to view and assess the damage. In February 2023, City work crews were finally able to remove both the felled tree and the roof structure debris, enabling EPBC's insurance carrier to complete its examination of the damage, resulting in a pay-out to EPBC of over \$100,000. Once all the debris was removed, EPBC members began repairing damaged benches, bocce ball boxes, picnic tables, bleachers, and the perimeter fencing.

Amazingly, a bocce club in Illinois, thousands of miles away, became aware of EPBC's efforts to rebuild through Sacramento's Channel 13 newscast segment and a “Good Day Sacramento” segment featuring the damaged courts. They were so moved after seeing the segment, that they held a fund-raising bocce tournament and donated the proceeds to the EPBC. Thanks to such fundraising efforts, along with EPBC's insurance carrier providing partial coverage and club members volunteering hundreds of hours of sweat equity, the courts were sufficiently repaired in time to make them playable for league play in spring 2023.

In 2024, EPBC volunteers and contractors coordinated with City staff to develop a workable plan to rebuild the pole barns. The City applied for federal disaster relief funds, but with no such relief forthcoming, EPBC committed to use its own insurance proceeds and reserves to hire a contractor to do the work. Just this past week, EPBC received a city building permit to do the work. The construction is scheduled to begin soon and be completed within two months. Best of all, the rebuild project, which is valued at more than \$200,000, will be accomplished through a combination of EPBC insurance proceeds, contractor expertise, community sweat and equity, and the work of many tireless volunteers - without any direct expense to the City!!!

By the time that EPBC completes the pole barn rebuild, EPBC will have spent over \$300,000 and devoted thousands of volunteer hours for materials, repairs, operation, and maintenance of the courts over the last 20 years alone. But let me be clear. This partnership would not have succeeded and would not continue to be successful without the hard work and dedication of City staff. We want to thank Ryan Moore, Assistant City Manager; Jackie Beecham, Director, City Youth, Parks, and Community Enrichment (YPCE); and Jason Weidemann, Manager, City Park Planning Division for their willingness to go above and beyond to make this partnership better than ever. Finally, we are deeply grateful to Councilmember Phil Pluckebaum for his leadership in bringing this lease and court reconstruction project to completion.

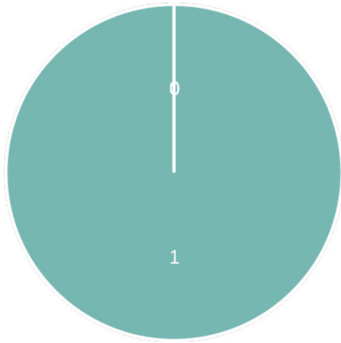
