

RESOLUTION NO. 2019-0389

Adopted by the Sacramento City Council

October 15, 2019

Approving the Rescission and Replacement of Resolution No. 2019-0049 to Establish a New Multi-Year Operating Project (MYOP) for the Local Hire and Community Workforce Training Program Implementation Project (I02002200)

BACKGROUND

- A. On August 21, 2018, the City Council adopted Ordinance No. 2018-0042, which amended Article VIII of Chapter 3.60 of the Sacramento City Code to authorize City Council to adopt, by resolution, a Local Hire and Community Workforce Training Program to promote and provide incentives for the hiring of local residents to perform work on City projects.
- B. On the same date, the City Council also approved a Community Workforce Training Agreement (CWTA) between the City and the Sacramento Building and Construction Trades Council.
- C. The Local Hire and Community Workforce Training Program and CWTA encourages contractors to hire local residents as employees. Promoting the hiring of residents of the seven-county region, with a priority provided to City of Sacramento residents, is expected to have direct economic benefits to the city, including employment and indirect sales taxes, and to develop increased numbers of local skilled construction workers and provide employment opportunities for emancipated youth, women, former offenders, veterans, persons receiving public assistance, youth interns and residents of targeted zip code areas.
- D. On February 12, 2019, the City Council authorized the City Manager or designee to enter into an agreement with the Sacramento Employment and Training Agency to coordinate with the City, its contractors and subcontractors, and union halls to determine which workers are residents of the local area and/or are priority apprentices under the Local Hire and Community Workforce Training Program, and established a multi-year operating project (MYOP) for local hire and community workforce training.
- E. The previously established MYOP number was subsequently assigned to another project, requiring that the Council now rescind the prior Resolution No. 2019-0049, and adopt a new Resolution establishing a new MYOP number.

**BASED ON THE FACTS SET FORTH IN THIS BACKGROUND, THE CITY COUNCIL
RESOLVES AS FOLLOWS:**

- Section 1. Resolution No. 2019-0049 is rescinded.
- Section 2. The Local Hire and Community Workforce Training Program Implementation Project (I02002200) is established as a new Multi-Year Operating Project.
- Section 3. The City Manager or the City Manager's designee is authorized to transfer \$100,000 in General Funds (Fund 1001) from the expenditure budget in the Convention Center Complex Renovation Project (M17100100) to the expenditure budget in the Local Hire and Community Workforce Training Program Implementation Project (I02002200).
