

## **RESOLUTION NO. 2021-0002**

Adopted by the Sacramento City Council

January 5, 2021

### **California Task Force Seven (CA-TF7) Urban Search and Rescue (US&R) Team Tropical Storm Dorian Deployment (G12704000) (Grant)**

#### **BACKGROUND**

- A. The City of Sacramento Fire Department has been the sponsoring agency for the CA-TF7 US&R Team since the inception of the Federal Urban Search & Rescue program in the early 1990's. CA-TF7 has responded for emergency assistance to the terrorist attack of the World Trade Center in New York, to the Gulf Coast in the aftermath of Hurricane Katrina, to the Oso Washington mudslides, and various other events.
- B. CA-TF7 can be deployed as an entire team, or individual Incident Support Team (IST) members, to provide overhead support to man-made and natural disasters; and national special security events.
- C. On September 3, 2019, CA-TF7's team members were activated by the Department of Homeland Security/Federal Emergency Management Agency (DHS/FEMA) for deployment to Tropical Storm Dorian.
- D. To receive reimbursement for costs associated with the deployment activities for the Tropical Storm Dorian deployment, the City must pass a resolution granting signature authority for the City Manager, or the City Manager's designee to sign Amendments M001, M002, and M003, respectively, regarding DHS/FEMA Assistance Award/Amendment No. EMW-2018-CA-USR-0008.

#### **BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. The City Manager or the City Manager's designee, including the Fire Chief, is authorized to execute Amendments M001, M002, and M003 to DHS/FEMA Assistance Award/Amendment No. EMW-2018-CA-USR- 0008.
- Section 2. The City Manager or the City Manager's designee, including the Fire Chief, is authorized to accept the federal funding for CA-TF7 US&R Team in the amounts of \$46,200, \$500,000, and \$46,200 for Amendments M001, M002, and M003, respectively, for a total amount of \$623,200.

Section 3. An operating grant shall be established for the CA-TF7 US&R Team Tropical Storm Dorian Deployment (G12704000).

Section 4. A revenue and expenditure budget in the amount of \$623,200 shall be established for the CA-TF7 US&R Team Tropical Storm Dorian Deployment (G12704000).
