Description/Analysis

Issue: The California State Parks Department, Division of Boating and Waterways (DBW), has awarded \$72,555 in federal grant funding to the Sacramento Police Department (SPD) for the Fiscal Year (FY) 2015/16 Boating Safety and Enforcement Equipment Grant program. This funding will provide SPD with the financial resources to replace major mechanical components in an existing Sacramento Police boat and to purchase two personal water crafts (PWCs). The term of this grant is for one federal year, beginning October 1, 2015 and ending September 30, 2016.

Policy Considerations: The recommendations contained in this report are consistent with Resolution 2015-0169, which requires City Council approval to establish an operating grant, when such action is required by the grantor as a condition of funding.

Economic Impact: Not applicable

Environmental Considerations: Not applicable

California Environmental Quality Act (CEQA): This proposal does not constitute a “project” and is therefore exempt from CEQA requirements, per the CEQA Guidelines, Sections 15061(b) (3) and 15378(a).

Sustainability Considerations: Not applicable

Commission/Committee Action: Not applicable

Rationale for recommendation: The Sacramento Police Marine Unit is responsible for over 30 miles of waterway, including the busiest portions of the Sacramento and American Rivers. Acceptance of the grant funding will allow SPD to repair an existing boat that is currently inoperable and add two PWCs to the unit. The repair of existing equipment and the addition of the PWCs will assist SPD with patrolling the waterways, search and rescue operations, and increase the safety and coverage of all boaters using the waterways.

Financial Considerations: This grant award will provide funding for the repairs of mechanical components in one of SPD’s patrol boats and the purchase of two PWCs. There is no cost match or sharing requirement associated with this funding.
