

ORDINANCE OF THE CITY OF SACRAMENTO DECLARING THE COUNCIL OF THE CITY OF SACRAMENTO TO BE MEMBERS OF THE REDEVELOPMENT AGENCY OF THE CITY OF SACRAMENTO, REPEALING ORDINANCE NO. 3208, FOURTH SERIES, AND DECLARING THIS ORDINANCE TO BE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

The Council of the City of Sacramento does hereby declare itself to be the Redevelopment Agency of the City of Sacramento as of 12:01 A.M. on February 1, 1973, and declares that at said time and date all of the rights, powers, duties, privileges and immunities vested by the Community Redevelopment Law in the Redevelopment Agency of the City of Sacramento shall be and are vested in said Council.

SECTION 2.

It is hereby declared that the offices of the existing Members of the Agency are vacated as of 12:01 A.M. on February 1, 1973 at which time the Council of the City of Sacramento shall become the Members of the Redevelopment Agency of the City of Sacramento.

SECTION 3.

This ordinance does not in any manner change the status of the Redevelopment Agency of the City of Sacramento, as a public body corporate and politic, as specified in Section 33100 of the Health and Safety Code of the State of California (Community Redevelopment Law), which Agency has continued and continues to exist as a legal entity without change since the date it was determined that there was a need for the Agency to function by Resolution No. 190, dated September 27, 1950.

SECTION 4.

Ordinance No. 3208, Fourth Series, is hereby repealed.

SECTION 5.

This ordinance is hereby declared to be an emergency measure to take effect immediately. The reason for the emergency is to change the date in which the City Council will become the Members of the

Redevelopment Agency of the City of Sacramento from January 1, 1973 to February 1, 1973, and to make said change prior to the effective date of Ordinance No. 3208, Fourth Series.

SECTION 6.

The City Clerk shall publish this ordinance once within 10 days after passage in the official newspaper of the City of Sacramento.
