A RESOLUTION AUTHORIZING THE REDEVELOPMENT
AGENCY AND THE HOUSING AUTHORITY TO EXECUTE
COMMUNITY DEVELOPMENT BLOCK GRANT PROJECTS

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

That the Redevelopment Agency of the City of Sacramento and the Housing Authority of the City of Sacramento are hereby authorized to undertake and complete the activities set forth in Sections 2 and 3 of this Resolution for which the City of Sacramento has received Federal funds pursuant to the Community Development Block Grant program in accordance with City agreements No. 76-129 and 76-130 executed on December 1, 1976.

SECTION 2.




