
Resultion of Intention No.



The improvement of the following in the City of Sacramento:

Carrousel Lane, Charqueen Drive and Cabana Way as the same are are shown on the official Plat of South Land Park Estates, filed in the office of the County Recorder of Sacramento County; Easterly One-Half of Del Rio Road from the Northerly line of Sutterville Road to the Southerly Boundary of said South Land Park Estates, produced Westerly; Sutterville Road from the Northerly production of the Easterly line of Lot 9 of said South Land Park Estates to a point located 950.00 feet Westerly from the center line of Del Rio Road and from said point Southerly in Sacramento County Drainage Canal, 75 feet;

Right-of Ways, owned by the City of Sacramento, in said South Land Park Estates Subdivision as follows:

Along the rear of Lots 1 to 9 both inclusive, Along rear of Lots 41 to 46 both inclusive and along Southerly line of Lots 48 and 1, Along the Easterly line of Lots 16 to 22 both inclusive and Lot 41, Along the Southerly line of Lot 18, Along the Southerly line of Lots 9 to 15 both inclusive, Along the Easterly line of Lots 30 and 33, and along rear of Lots 33, 34, 35, rear of Lot 36 and along Southerly line of Lots 36 and 24,

by removing and disposing of all refuse and surplus materials; grading and constructing concrete curbs, gutters and sidewalks; installing castiron gutter drains and connecting same to sewer system with vitrified clay sewer pipe; installing vitrified clay pipe sewer; installing galvanized corrugated metal pipe, including 45 feet bore under Railroad; constructing a concrete manhole complete with cast-iron curb and cover; installing vitrified clay sewer pipe wyes; constructing a Water Distribution System, complete; grading and constructing an asphaltic concrete pavement.

All of said work to be done in accordance with the "Standard Specifications of the City of Sacramento, heretofore adopted by the City Council and also in accordance with detailed Plans and Special Provisions made

therefore by the City Engineer and on file in his office having been approved by the City Council on June 4th, 1952, and

WHEREAS, said City Council has found and determined that pursuant to Section 2804 of Division 4 of the Streets and Highways Code of the State of California, the Owners of more than 60% of the Area of the property subject to Assessment for the above described improvement, have signed and filed with the City Clerk, a written petition and said Owners did in said petition WAIVE the proceedings required by the Special Assessment, Investigation, Limitation and Majority Protest Act of 1931", and the said City Council does hereby approve of said WAIVER and resolves to commence proceedings as provided in Division 7 of the Streets and Highways Code, "THE IMPROVEMENT ACT OF 1911."

And whereas, in the opinion of said City Council said work is of more than local and ordinary public benefit, said Council hereby orders that the costs and expenses of said work and improvement shall be chargeable and charged upon a district of lands, which district is hereby declared to be the district benefited by said work and improvement and which is to be assessed to pay the costs and expenses thereof.

The exterior boundaries of said district and the extent of the territory included therein are shown upon the map of said district adopted and approved by the City Council on June 4th , 1953, which map is now on file in the office of the City Engineer and to which reference is hereby made for a particular description of the boundaries of said district and of the extent of the territory included therein;

Saving and excepting from the above bounden and described district the area of all public streets, alleys, ways, boulevards, courts and avenues included therein.

Notice is hereby given that serial bonds to represent unpaid assessments and bear interest at the rate of <u>four</u> (4%) per cent per annum will be issued hereunder in the manner provided by the "Improvement Bond Act of 1915." the last installment of which bonds shall mature **fourteen** (14) years from the second day of July next succeeding ten (10) months from their date.

All persons objecting to said work, or to the extent of said assessment district, are required to file their objections in writing in the office of the City Clerk of the City of Sacramento, as required by law, and notice is hereby given to all persons interested that on the 25th day of June, 19 53 at eight o'clock p. m., in the Council Chamber of the City Council of the City of Sacramento, in the City Hall, on "I" Street, between 9th and 10th Streets, in said City, any and all persons having any objections to the proposed work and improvement may appear before said City Council and show cause why the proposed work and improvement shall not be carried out in accordance with this Resolution.

And the City Clerk is hereby directed to publish this Resolution twice in the Union , a daily newspaper, as required by law.
