RESOLUTION FIXING A HEARING DATE TO DETERMINE
COSTS AND TO IMPOSE COSTS OF SIDEWALK REPAIR
AS A LIEN

WHEREAS pursuant to the provisions of Chapter 38 of the Sacramento City Code and the Improvement Act of 1911, the Superintendent of Streets has directed that repairs be made to sidewalks located at the address hereinafter set forth, and

WHEREAS the owners of said property failed to repair said defective sidewalks as required by said provisions, and

WHEREAS the Superintendent of Streets ordered that said repair work be done by the City and the costs of same be made a lien upon the property, payable with regular City taxes, and

WHEREAS said work has been done by contractors of the City, and

WHEREAS the owners of the property upon which the sidewalk repairs were made have not voluntarily paid the City for the costs of said repair,

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. That the City Council hold a hearing before it on September 3, 1970 in the City Council Chambers, 915 I Street, Sacramento, California, to hear and consider all protests, if there shall be any, and then affirm or reject the placing of the costs of such sidewalk repairs upon such property as a lien, payable with regular City taxes.
2. The property upon which said sidewalk repairs have been made, the repair order, and proposed lien is as follows:
