

The SOL Project is grateful for Sacramento's leadership on public health issues and its initial efforts to ban menthol and flavored tobacco in 2018—one of the strongest policies in the state at the time. However, we are concerned that the "healthy food" exemption, adopted in 2020, has unintentionally undermined these efforts. The exemption has not increased access to healthy food in designated food deserts as intended. Instead, it has allowed 27 retailers—many not located in food deserts—to regain tobacco retail licenses. Since 2018, a total of 71 new licenses have been issued. According to the California Department of Tax and Fee Administration, there are now 346 tobacco retailers in Sacramento, with 20.5% located within 1,000 feet of a school. This trend is alarming and counterproductive to reducing access to tobacco products in our community.

The exemption has also created enforcement challenges. It requires code enforcement to measure store space to verify compliance, which varies by location. The lack of a clear definition for "healthy, fresh food" has lowered the standard for what qualifies and opened loopholes for retailers to reinstate licenses or obtain new ones in areas that are not food deserts.

My name is Blythe Young, I am a Community Advocacy Director for The American Heart Association and a Sacramento Resident. The American Heart Association supports strengthening the City of Sacramento's Tobacco Retail License Ordinance through the removal of the "healthy food exemption" and considering additional best practice elements. To achieve the City's goal of reducing tobacco use, it is vital to close this loophole that has allowed for an increase in the number of retailers and has no clear definition of "healthy food". Further strengthening of this policy will reduce access to the products that are the tobacco industry's key strategy for targeting and addicting new smokers, Sacramento's youth.

While Sacramento was a leader in 2018 with the passage of a Tobacco Retail License, the policy could be strengthened to 2025 standards by including: a minimum of one codified compliance inspection per year; a fee that covers the full enforcement costs for annual compliance inspections; an explicit statement that the owner/operator is responsible for any monetary fines; an explicit statement that individuals will not be punished for purchase, use or possession.

Cigarette smoking remains the leading cause of preventable disease and death in the United States, claiming on average 480,000 lives each year. Evidence shows that smoking increases the risk for heart disease and stroke. It increases the risk for blood clots, decreases the ability to exercise, and decreases the good cholesterol in our bodies. The best way to prevent tobacco-related illness and death is to prevent people from starting to smoke in the first place.

Closing the loophole created by the "healthy food exemption" and considering additional elements to strengthen the TRL will help protect our community from tobacco addiction and is crucial to preventing tobacco-related death and disease. Re: Updating the Tobacco Retail License Policy and removing the "Healthy Food" exemption

Dear Mayor McCarty, Vice Mayor Maple and Council Members,

The Greater Sacramento Smoke and Tobacco Free Coalition supports updating the Tobacco Retail Licensing (TRL) policy and removing the healthy food exemption.

Sacramento City Code 5.138.040 (B)(2) provides an exemption to the 1,000-ft density requirement to "a licensee that devotes no more than 5% of total shelf space to tobacco product and at least 10% of shelf space to fresh or healthy food." This exemption is a burden to code enforcement who are required to measure store space to determine if the law is being met at each unique location. Additionally, what constitutes a "healthy, fresh food" has not been defined, creating a loophole for retailers to reinstate expired or terminated licenses or obtain new licenses in non-food desert areas.

The initial adoption of the menthol and flavored tobacco ban in 2018 was a huge step in protecting our community from the harms of commercial tobacco products. Unfortunately, the adoption of a "healthy food" exemption in 2020 did not increase access to healthy food within designated food deserts as intended, and as a result of this loophole, 27 retailers used the exemption to gain their tobacco retail licenses – notably, many of these are not located in food deserts. Additionally, 44 retailers have also received licenses for a total of 71 new retailers since 2018. According to the California Department of Tax and Fee Administration, there are 346 tobacco retailers, and 20.5% are located within 1,000 feet of a school. With this increase, Sacramento is headed in the wrong direction for eliminating access to tobacco and nicotine products.

To ensure that the TRL ordinance works as originally intended and to decrease the amount of tobacco products accessible to community members, particularly to youth and other vulnerable populations, we urge this Council to remove the healthy food exemption, in its entirety, from city code.

Thank you for your ongoing commitment and leadership to create healthy communities in Sacramento. The Coalition is happy to assist the City with any ongoing improvements to the TRL program such as phasing out the sale of tobacco, ensuring adequate licensing fees for enforcement and clean up of tobacco waste, and making licenses non-transferable to reduce retailer density.

Dear Mayor and City Council,

The American Heart Association supports strengthening the City of Sacramento's Tobacco Retail License Ordinance through the removal of the "healthy food exemption" and considering additional best practice elements. Further strengthening of this policy will reduce access to the products that are the tobacco industry's key strategy for targeting and addicting new smokers, Sacramento's youth.

While Sacramento was a leader in 2018 with the passage of a Tobacco Retail License, the policy could be strengthened to 2025 standards by including: a minimum of one codified compliance inspection per year; a fee that covers the full enforcement costs for annual compliance inspections; an explicit statement that the owner/operator is responsible for any monetary fines; an explicit statement that individuals will not be punished for purchase, use or possession.

Cigarette smoking remains the leading cause of preventable disease and death in the United States, claiming on average 480,000 lives each year. Evidence shows that smoking increases the risk for heart disease and stroke. It increases the risk for blood clots, decreases the ability to exercise, and decreases the good cholesterol in our bodies. The best way to prevent tobacco-related illness and death is to prevent people from starting to smoke in the first place.

Closing the loophole created by the "healthy food exemption" and considering additional elements to strengthen the TRL will help protect our community from tobacco addiction and is crucial to preventing tobacco-related death and disease. The American Heart Association respectfully asks for your support of this vital amendment.





Law enforcement provided forgery investigation reports is criminal activity and obstruction of justice. In 2-20-2024, my first public comment at Sacramento City Council meeting about SPD providing forgery reports for my father's death. <u>City Manager was there.</u> It has been almost one year but Sacramento City government is still not taking any action against SPD. Now, I still don't know who killed my father and don't have the statement from the person who killed my father. Below is the information about the incident.

On 8-18-2023, SPD staff # 6253 rejected the request with reason "Rpt/WC" and "WC Cantonese". In early September 2023, I picked up the form SPD810 at SPD HQ Record Office and I was given the forgery investigation report 99-83081. In May 2024, SPD Captain Brian Kinney emailed me the same forgery reports.

<u>Forgery investigation report 99-83081:</u> (see attached 99-83081) Party 1, 2 and 3 are missing from the report. *"#1* BOOKED" but Jone Soo Fong is *"PARTY 4"*. SPD refused to present the report 99-83081 in front of the camera of Sacramento City Council Meeting.

I filed complaint to OPSA Director against SPD in May 2024 and to Ethics Commission against City Manger and OPSA Director in June 2024. Both City Manager and OPSA Director violated Sacramento City Code "4.02.030" "Break the public trust". However, Ethics Commission and City Clerk used "No jurisdiction" as a reason to dismiss my complaint. My father was killed in downtown Sacramento, I received the forgery reports from SPD staff inside SPD headquarters and the email from Captain Brian Kinney.
