**SUBJECT: State of California – Racial Profiling  
Assembly Bill 788 (AB788) Support Letter**

**LOCATION AND COUNCIL DISTRICT:** City-wide

**RECOMMENDATION:**

It is recommended that the Law and Legislation Committee review and recommend for City Council approval of the attached proposed letter of support for a California State legislature bill pertaining to racial profiling, Assembly Bill 788.

**SUMMARY:**

This report provides information on a bill now active before the California State Legislature, Assembly Bill 788 (AB788). If passed and approved by the Governor, this bill would redefine “racial profiling” and create a civil cause of action with minimum damages.

**COMMITTEE/COMMISSION ACTION:** None.

**BACKGROUND:**

Existing law prohibits law enforcement officers from engaging in racial profiling and requires that they participate in racial profiling training. Additionally, it requires the Legislative Analyst to present a report to the Legislature regarding data collection as it applies to racial profiling.

AB788 would change the definition of racial profiling and allow race, national origin, or ethnic origin as a consideration, along with physical characteristics, in determining who to detain, apprehend or search. In addition, it requires agencies that receive grants for traffic stop data

collection to provide annual reports on the data. Finally, AB788 requires the California Highway Patrol and specified law enforcement agencies to report the data collection statistical information (excluding any information that reveals the officer's identity or the identity of the person stopped) to the Legislative Analyst until 2011.

This bill is consistent with the Police Department's commitment to provide the best, unbiased professional service to every segment of our community and address the issue of racial profiling.

**FINANCIAL CONSIDERATIONS:**

This bill would create a civil cause of action against law enforcement officers and law enforcement agencies for a minimum of \$5,000 in damages and attorney fees as determined by the court.

**POLICY CONSIDERATIONS:**

Support of this legislation is consistent with the City's efforts to address issues regarding racial profiling.


**ENVIRONMENTAL CONSIDERATIONS:**


