

RESOLUTION No. 75-243

Adopted by The Sacramento City Council on date of  
May 29, 1975

A Resolution Designating Streets Subject  
to Restricted Parking

WHEREAS, under and by virtue of Section 25.84 of Division I, Article IV, Chapter 25 of the Sacramento City Code, it is deemed necessary for the protection of the traveling public to prohibit stopping, standing, or parking during certain hours on certain streets.

BE IT THEREFORE RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That when signs are erected giving notice thereof, no person shall stop, stand, or park any vehicle upon any of the following described streets or parts of streets between the hours specified on said signs.

Alhambra Boulevard between L Street and Capitol Avenue on the west side only;

Balboa Circle;

Bidwell Way between Freeport Boulevard and 19th Street on the north side only;

Bidwell Way between Freeport Boulevard and the Western Pacific tracks on the south side only;

Broadway between 59th Street and 60th Street on the south side only;

Caleb Avenue between Sandburg Drive (West) and Sandburg Drive (East);

Carlson Drive between Camellia Avenue and Shepard Avenue on the north side only;

Carlson Drive between Sandburg Drive (North) and State Avenue

Castro Way between 24th Street and 25th Street on the south side only;

Cisco Circle;

Colonial Way between Stockton Boulevard and Sherman Way;

D Street between La Purissima Way and 45th Street on the south side only;

Dickson Street between Belleau Wood Lane and Zelda Way on the south side only;

E Street between Coloma Way and 270' Easterly;

El Monte Avenue between Gibson Street and Hawthorne Street;

F Street between 8th Street and 9th Street on the south side only;

Fairfield Street between Arcade Boulevard and Las Palmas Avenue;

Freeport Boulevard between 4th Avenue and Sutterville Road;

Front Street between Capitol Mall and Q Street on the east side only;

G Street between 27th Street and 28th Street on the south side only;

Grand Avenue between Alder Street and Fig Street;

Hale Court;

Harte Way between Joaquin Way and Hollywood Way on the north side only;

I Street between 7th Street and 8th Street on the south side only;




