Adopted by The Sacramento City Council on date of

April 19, 1962

RESOLUTION ORDERING, PROCLAIMING, CALLING, GIVING NOTICE OF, AND PROVIDING FOR THE HOLDING OF A SPECIAL ELECTION FOR THE PURPOSE OF SUBMITTING TO THE ELECTORS RESIDING IN THE TERRITORY HEREINAFTER PARTICULARLY DESCRIBED AND COMMONLY KNOWN AS "GARDENLAND-DEL PASO HEIGHTS-ROBLA ANNEXATION AREA," THE QUESTION OF WHETHER SUCH TERRITORY SHALL BE ANNEXED TO, INCORPORATED IN AND MADE A PART OF SAID CITY OF SACRAMENTO, AND ALSO ESTABLISHING ELECTION PRECINCTS THEREFOR, DESIGNATING THE POLLING PLACES THEREIN, AND APPOINTING BOARDS OF ELECTION OFFICERS.

WHEREAS, there has been submitted to said City Council a written petition signed by not less than one-fourth in number of the qualified electors residing within the territory hereinafter described, as shown by the registration of voters of the County of Sacramento, asking that such territory be annexed to the City of Sacramento, a municipal corporation; and

WHEREAS, the property owners' protest hearing was thereafter duly and regularly set for 7:45 p.m. on Thursday, April 19, 1962, in the Council Chamber in the City Hall, at 9th and I Streets, Sacramento, California, publication of notice of time and place of hearing having been published for the time and in the manner as prescribed by law, and said hearing having been duly held by the Council at said time and place aforesaid, and as a result of said hearing that the owners of one-half of the value of the territory proposed to be annexed, commonly known as "GARDENLAND-DEL PASO HEIGHTS-ROBLA ANNEXATION AREA," as shown by the last equalized assessment roll, have not made protests against holding an annexation election;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the Council hereby finds and declares that protests were not made by the owners of one-half of the value of the territory proposed to be annexed, commonly known as "GARDENLAND-DEL PASO HEIGHTS-ROBLA ANNEXATION AREA," as shown by the last equalized assessment roll.

That a Special Municipal Election is hereby ordered, proclaimed and called for Thursday, June 14, 1962, for the purpose of submitting to the electors residing in the territory hereinafter described, the question whether such territory shall be annexed to the City of Sacramento, a municipal corporation.

That the territory above referred to, and proposed to be annexed, is contiguous to the corporate limits of the City of Sacramento, and is particularly described as follows:

Beginning at a point on the City Limits line of the City of Sacramento, said point further described as the interception of the center lines of San Juan Road and Northgate Boulevard; thence northerly along the center line of Morthgate Boulevard to its interception with the westerly production of the southerly boundary of the certain property deeded to John A. and Ellen J. Jacobson by Natomas Company, as recorded in the Official records of the County Recorder of Sacramento County in Book 1215, File 10707; thence easterly along said production and the southerly boundary of said property to its interception with the center line of East Levee Road; thence Northerly alogg the center line of said East Levee Road to its interception with the center line of Del Paso Road; thence westerly along the center line of said Del Paso Road to its interception with the center line of Sorento Road; thence northerly along the center line of said Sorento Road to its interception with the center line of said East Levee Road; thence southerly along the center line of said East Levee Road to its interception with the westerly production of the center line of "A" Street; thence easterly along said production and the center line of said "A" Street to its interception with the center line of West Second (2nd) Street; thence southerly along the center line of said West Second (2nd) Street to its interception with the center line of said "A" Street; thence easterly along the center line of said "A" Street and its easterly production to the westerly boundary line of lands belonging to the Federal Government of the United States, commonly known as McClellan Field; thence generally southerly along the irregular westerly boundary of said lands and its southerly production to its interception with the center line of North Avenue, said point being located between Winters Street and Tate Street; thence westerly along the center line of said North Avenue to its intersection with the center line of Pinell Street; thence southerly along the center line of said Pinell Street to its interception with the center line of South Avenue; thence westerly along the center line of said South Avenue to its intersection with the easterly right of way line of the Sacramento Northern Railroad; thence southerly along said easterly right of way line of said railroad to its intersection with the center line of Arcade Creek; thence westerly along the meandering center line of said Arcade

Creek and the City limits line of the City of North Sacramento to its interception with the southerly production of the center line of Taylor Street; thence northerly along the center line of said Taylor Street to its interception with the westerly production of the center line of North Avenue; thence easterly along said production to its interception with the westerly right of way line of Rio Linda Boulevard; thence northerly along the westerly right of way line of said Rio Linda Boulevard to its interception with the center line of Main Avenue; thence westerly along the center line of said Main Avenue to its interception with the center line of the City of North Sacramento; thence generally westerly and southerly along the city limits line of said city of North Sacramento to its intersection with the center line of Northgate Boulevard, said point also being a point on the City Limits line of the City of Sacramento; thence Northerly along the City Limits line of said City of Sacramento and the center line of Northgate Boulevard to the paint of beginning

That the City Clerk is further ordered and instructed to have printed the Notice of Election hereinafter set forth in the RIO LINDA RECORD, a newspaper of general circulation, printed and published outside the City of Sacramento but in the County of Sacramento, once a week for four weeks prior to the date of such election; that such election shall be in form substantially as follows:

"NOTICE OF SPECIAL ELECTION ON A PROPOSAL TO ANNEX CERTAIN INHABITED TERRITORY COMMONLY KNOWN AS 'GARDENLAND-DEL PASO HEIGHTS-ROBLA ANNEXATION AREA' TO THE CITY OF SACRAMENTO.

NOTICE IS HEREBY GIVEN that on Thursday, June 14, 1962, a special election will be held and conducted in that certain territory hereinafter particularly described, for the purpose of submitting to the electors in said territory, the question whether such territory shall be annexed to, incorporated in, and made a part of the City of Sacramento, a municipal corporation. The electors in such territory are hereby notified and directed to vote upon such question in the manner hereinafter set forth. The entire property proposed to be annexed to the City of Sacramento shall be in voting precincts. That the location of the polling places and the names of the election officers for said precincts shall be as follows:

The polls for said election shall be opened at 7:00 a.m. on the day of said special election and shall be kept open until 7:00 p.m. of said day, when the polls shall be closed, except that if at the hour of closing there are any voters in the polling place or in line at the door who are qualified to vote, and who have not been able to do so since appearing, the polls shall be kept open a sufficient time to enable them to vote, but no one who shall arrive at the polling place after 7:00 p.m. of said day shall be entitled to vote, although the polls may be open when they arrive.

That the territory proposed to be annexed is situate in the County of Sacramento, State of California, and is particularly described as follows:

Beginning at a point on the City limits line of the City of Sacramento, said point further described as the interception of the center lines of San Juan Road and Northgate Boulevard; thence northerly along the center line of Northgate Boulevard to its interception with the westerly production of the southerly boundary of the certain property deeded to John A. and Ellen J. Jacobson by Natomas Company, as recorded in the Official records of the County Recorder of Sacramento County in Book 1215, File 10707; thence easterly along said production and the southerly boundary of said property to its interception with the center line of East Levee Road; thence Northerly along the center line of said East Levee Road to its interception with the center line of Del Paso Road; thence westerly along the center line of said Del Paso Road to its interception with the center line of Sorento Road; thence northerly along the center line of said Sorento Road to its interception with the center line of said East Levee Road; thence southerly along the center line of said East Levee Road to its interception with the westerly production of the center line of "A" Street; thence easterly along said production and the center line of said "A" Street to its interception with the center line of West Second (2nd) Street; thence southerly along the center line of said West Second (2nd) Street to its interception with the center line of said "A" Street; thence easterly along the center line of said "A" Street and its easterly production to the westerly boundary line of lands belonging to the Federal Government of the United States, commonly known as McClellan Field; thence generally southerly along the irregular westerly boundary of said lands and its southerly production to its interception with the center line of North Avenue, said point being located between Winters Street and Tate Street; thence westerly along the center line of said North Avenue to its intersection with the center line of Pinell Street; thence southerly along the center line of said Pinell Street to its interception with the center line of South Avenue; thence westerly along the center line of said South Avenue to its intersection with the easterly right of way line of the Sacramento Northern Railroad; thence southerly along said easterly right of way line of said railroad to its intersection with the center line of Arcade Creek; thence westerly along the meandering center line of said Arcade

Creek and the City limits line of the City of North Sacramento to its interception with the southerly production of the center line of Taylor Street; thence northerly along the center line of said Taylor Street to its interception with the westerly production of the center line of North Avenue; thence easterly along said production to its interception with the westerly right of way line of Rio Linda Boulevard; thence northerly along the westerly right of way line of said Rio Linda Boulevard to its interception with the center line of Main Avenue; thence westerly along the center line of said Main Avenue to its interception with the center line of Said Main Avenue to its interception with the center line of Taylor Street, said point also being a point on the City limits line of the City of North Sacramento; thence generally westerly and southerly along the city limits line of said city of North Sacramento to its intersection with the center line of Northgate Boulevard, said point also being a point on the City Limits line of the City of Sacramento; thence Northerly along the City Limits line of said City of Sacramento and the center line of Northgate Boulevard to the paint of beginning.

All of the above subdivisions are according to the map or plat of same on file in the office of the County Recorder of Sacramento County, State of California.

Said above-described territory is hereby designated, and in connection with said election shall be referred to and indicated upon the ballots to be used at such election as "GARDENLAND-DEL PASO HEIGHTS-ROBLA ANNEXATION AREA."

If annexed, said territory will not be required to assume any of the present outstanding bonded indebtedness of the City.

The ballots to be used at such special election shall be made in the form and printed as follows:

PROPOSITION

Shall the territory generally known as : "GARDENLAND-DEL PASO HEIGHTS-ROBLA : ANNEXATION AREA" be annexed to the City : of Sacramento?

Each voter to vote FOR the proposition hereby submitted shall stamp a cross (X) in the voting square after the word 'YES' on the ballot to the right of said proposition, and to vote AGAINST said proposition shall stamp a cross (X) in the voting square after the word 'NO' on the ballot to the right of said proposition."

BE IT FURTHER RESOLVED that the salary of the Inspector of Election shall be \$12.00 each, and all other officers of the Board \$10.00 each.

BE IT FURTHER RESOLVED that the rental of the Polling Places for said Election shall be fixed at not to exceed the sum of \$10.00 each (inclusive of electricity for lighting purposes).
