Call to Order – 6:35 p.m.

The meeting was called to order by Jeff Harris, Chairperson, at 6:35 p.m. Commissioner Guadiana was absent. Commissioner Heitstuman arrived at 7:00 p.m. and Commissioner Ruggieri arrived at 7:35 p.m. All other commissioners were present.

Public Comments- Matters Not on the Agenda

1. Marni Leger spoke to the need for restrooms in South Natomas Community Park. Annette Deglow with the College-Glen Neighborhood Association requested the Commission discuss Council actions regarding revenues from telecommunication facilities in City parks and revenues from City owned billboards. Marc Brandes spoke to Chavez, Fremont and Muir Parks and recommended an evaluation of redesigns that either removed seating and/or designated a park for children.

2. **Request for Reconsideration of the Decision of the Parks and Recreation Commission to Deny the Removal and Replacement of Three (3) City Street Trees at 1517 and 1531 N Street**
Location: 1517 and 1531 N Street
Recommendation: Support the Request of UrbanCore Development and the Capital Area Development Authority for reconsideration of the Commission's decision to deny the request to remove three (3) City Street Trees based on new information regarding the difficulty and costs to protect the trees during construction.

Representatives from the Capital Area Development Authority (CADA) and the project developer described actions taken since the May 1, 2014 tree appeal hearing to comply with the ruling to retain and protect three Chinese Pistache street trees on the project site. They spoke to construction challenges and added cost to protect the trees given the need for site excavation and adequate space for crane operations.

The appellant, Ms. Leilani Fay, testified and objected to the development and design process, the lack of consideration to preserve shade canopy trees, and to removing the trees in question. Testimony was also heard from Ms. Fay's representative, Council Member Hansen and his staff, and a landscape architect for the project.

Commissioners and CADA staff discussed the project, CADA's overall approach to existing City street trees surrounding their projects, new replacement tree selection considerations, additional sites for street trees in the downtown area, and the lack of setback requirements on new buildings that would better accommodate large tree shade canopies.

Action: Moved, seconded and carried to support the removal of three Chinese Pistache trees and replace them with the largest caliper tree the City Arborist recommends. To mitigate the loss of these three trees and their shade canopy, twelve (12) new City street trees are to be paid for and installed by the applicant in locations selected by the City and in the vicinity of the project site. Specific planting locations, tree species and caliper size are to be determined by City of Sacramento's Urban Forestry Section.
