SUBJECT: Relief Cashier FTE's

SUMMARY

This report provides information regarding the need for Relief Cashier FTE's at the Sacramento Zoo, Fairytale Town, Sacramento History Center, Science Center, and Crocker Art Museum. Further, this report recommends that the FY 1988-89 City operating budgets of these facilities be amended by adding a total of 1.16 FTE's. No additional City funds are requested.

SUBJECT: Relief Cashier FTE's

SUMMARY

This report provides information regarding the need for Relief Cashier FTE's at the Sacramento Zoo, Fairytale Town, Sacramento History Center, Science Center, and Crocker Art Museum. Further, this report recommends that the FY 1988-89 City operating budgets of these facilities be amended by adding a total of 1.16 FTE's. No additional City funds are requested.

BACKGROUND INFORMATION

The Department of Parks and Community Services is responsible for the operational budgets of the Sacramento Zoo, Fairytale Town, Sacramento History Center, Science Center, and Crocker Art Museum. Each of these special facilities employs at least one cashier who is responsible for charging and accounting for entry fees. All of these facilities are open to the public year-round. In addition, attendance at these cultural and educational resources continues to increase significantly each year.

In FY 1987-88, the Zoo Division (Zoo and Fairytale Town) spent nearly \$8,700 in overtime, out-of-class time, outside employment agency costs, and senior staff time in order to adequately cover cashier duties. This amount does not include benefits paid nor time and effectiveness lost on other duties when senior staff must act as cashiers. The Zoo Division currently employs one full-time and four part-time cashiers. Four out of five of these personnel must work every weekend. Serious scheduling problems occur if just one cashier is sick or on vacation.

Also, over the past fiscal year, both the History Center and Science Center have been functioning with just two cashiers. When one of these cashiers is sick or on vacation, other full-time staff must fill in, from the Typist Clerk II at the Science Center, to the Chief Museum Attendant and History Center Administrator at the History Center. The History Center only employs six full-time employees to keep the museum open 362 days per year. As with the Zoo Division, both facilities lose time, effectiveness, and money when other staff must cover cashier duties.

For the past two years, the Crocker Art Museum has utilized cashiers from an outside employment agency to cover the times when the City-employed cashier is unavailable. This has amounted to an average of 576 hours and over \$5,000 annually.

Recently, the City Personnel Department established a list of Relief Cashiers which will be utilized by the Department of Parks and Community Services. The Relief Cashier position will be non-career, limited term, part-time (1,040 hours per year), and remain at Step A of the Cashier salary (\$8.267 per hour in FY 1988-89).

It is estimated that the Relief Cashier position will be utilized by Parks and Community Services as follows:

FINANCIAL DATA

In order to provide better public service as well as cost effectiveness in use of personnel at the Sacramento Zoo, Fairytale Town, Sacramento History Center, Science Center, and Crocker Art Museum, it is necessary to add a total of 1.16 FTE Relief Cashiers to the FY 1988-89 City operating budget for these facilities. No additional city funds are requested.

RECOMMENDATION

It is recommended that the Budget and Finance Committee approve this report and refer it to the full City Council for action. Further, it is recommended that City Council, by resolution, add a total of 1.16 FTE Relief Cashiers to the FY 1988-89 City operating budget for the Department of Parks and Community Services (Zoo, Museum and History, and Crocker Art Museums).
