ORDINANCE NO. 389 , FOURTH SERIES.

AN ORDINANCE REGULATING THE USE AND OPERATION OF AIRCRAFT OVER THE CITY OF SACRAMENTO AND PROVIDING A PENALTY FOR THE VIOLATION OF SAID ORDINANCE.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO, AS FOLLOWS:

SECTION 1: The term "ATRCRAFT", as used in this ordinance, shall include every kind of vehicle or structure intended for use as a means of transporting persons or goods, or both, in the air; the word "FLY" or the word "FLIGHT" shall include every kind of locomotion by an air-craft; the words "AERIAL ACROBATICS" shall include any manipulation of the controls of an aircraft which tends, or may tend, to divert said aircraft from a normal flight in a horizontal plane parallel to the surface of the earth, save and excepting only such manipulation of the controls as may be necessary to cause the aircraft to ascend or descend from one altitude to another by means of a gradual ascent or descent with every consideration for stability and safety.

SECTION 2: No person shall, except at the beginning or end of a flight, fly or operate any aircraft over any part or section within the limits of the City of Sacramento, at a height lower than fifteen hundred feet.

SECTION 3: No person shall begin or terminate any flight at any place within the limits of the City of Sacramento, other than at a regularly established flying or landing field, especially designated as such by the City

Council of the City of Sacramento, and operated in accordance with regulations which are now, or which may hereafter be, prescribed by said City Council of the City of Sacramento, save and except only in the event of an emergency which makes it necessary to terminate said flight at a place other than such regularly established flying or landing fields in order to avoid death or injury to the occupants of the aircraft flown or operated by said person.

SECTION 4: No person shall engage in aerial acrobatics over any part or section within the limits of the City of Sacramento.

SECTION 5: No person shall fly or operate any aircraft over any uncovered inclosure within the limits of the City of Sacramento, wherein an assemblage of one hundred (100) or more persons is gathered.

SECTION 6: No person in or on any aircraft, or in or on anything attached thereto, shall drop, or cause or permit to be dropped from such aircraft or from anything attached thereto, any articles except sand or water ballast not in containers at the time of being dropped.

SECTION 7: Any person or persons flying or operating an aircraft over any part or section within the limits of the City of Sacramento who violates any of the provisions of this ordinance shall be guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not more than Five Hundred Dollars (\$500.00), or by imprisonment for not more than six (6) months, or by both such fine and imprisonment.
