SUBJECT: Crocker Art Museum Central HVAC Plant - CAMA Contribution

SUMMARY

The Crocker Art Museum Association has authorized \$230,000 toward the Crocker heating and air conditioning capital project. A budget amendment is necessary.

BACKGROUND INFORMATION

The heating and cooling equipment at the Crocker Art Museum facility is inadequate to maintain the constant temperature and humidity controls necessary to preserve the City's art collection valued at over \$10 million. The equipment is antiquated and subject to frequent breakdown. Furthermore, the present boiler is located in the portion of the condemned annex, which is scheduled for demolition in June 1986 as part of the approved master plan, and must be relocated during construction (June 1986 - January 1988). The amount of \$395,000 has been approved in the FY 1986 CIP budget to fund the upgrading of the HVAC systems at the Crocker in conjunction with the master plan.

Facilities Management has conducted a comprehensive study of the HVAC needs at the Crocker, and recommends the construction of a central HVAC plant, which will serve the existing buildings, the Phase II expansion, and could ultimately be expanded to accommodate the climate control needs of the entire master plan. A central plant would result in energy savings, maintenance cost savings, and noise abatement.

FINANCIAL DATA

The City allocated \$395,000 toward this capital project and the Crocker Art Museum Association has authorized \$230,000 from their Building Fund for this project. The CIP budget must be amended to reflect the additional funding.


