SUBJECT: City/County Participation in State/Local Partnership Program and Appropriation Increase for Metropolitan Arts Division

### SUMMARY

This report recommends that the City of Sacramento participate jointly with the County of Sacramento and its designated arts agency (Sacramento Metropolitan Arts Commission) in the California Arts Council's 1980-81 State/Local Partnership Program and to increase the FY 1980-81 budget of the Metropolitan Arts Division by \$12,000 for funds relating to this program.

### BACKGROUND INFORMATION

The California Arts Council and the State Legislature have established a new State/Local Partnership Program for the arts. The total budget for this program is \$1,050,000.

The program consists of two parts:

- (1) A planning phase - makes available immediately a \$12,000 non-matching planning grant to each county in the state for the purpose of developing a local arts plan; and
- (2) Implementation of the plan - based on the local arts plan, selected counties will be awarded a matching grant to implement the plan. This phase is expected to begin sometime after June 1981.

To participate in this program, each county must designate the appropriate agency to develop this plan. Formal adoption by the county and any city within which represents at least 20% of total county population is required. Since the Sacramento Metropolitan Arts Commission is a joint City/County agency, resolutions are necessary for participation in this program from both the Board of Supervisors and the City Council.

On September 11, 1980, the Sacramento County Board of Supervisors approved resolution number 80-1157 designating the Sacramento Metropolitan Arts Commission as the arts planning agency for the purpose of participating in the State/Local Partnership Program.

FINANCIAL DATA


The program makes available \$12,000 in non-matching funds for the planning phase. Participation in this phase does not require City or County funds. The appropriation increase will be supported by revenue provided by the California Arts Council upon receipt of a signed contract and an invoice.

RECOMMENDATION

It is recommended that the City Council approve the following resolutions:

- (1) A resolution approving joint participation with the County of Sacramento and its designated agency (Sacramento Metropolitan Arts Commission) in the California Arts Council's 1980-81 State/Local Partnership Program.
- (2) A resolution to increase appropriations to the Metropolitan Arts Division by \$12,000 for the purpose of participating in the California Arts Council's 1980-81 State/Local Partnership Program.
