SUBJECT:

- 1. Environmental Determination (Exempt 15115)
- 2. Tentative Map (P-9388)

LOCATION: Northeast corner of Dos Rios Avenue and North B Street

SUMMARY

This is a request to divide 8.5+ acres into three parcels in the M-2 Heavy Industrial zone. The purpose of the division is to develop three office/commercial buildings on individual sites. The staff and Subdivision Review Committee recommend approval of the request subject to conditions.

BACKGROUND INFORMATION .

The subject tentative map does not necessitate Planning Commission review because there are no concurrent applications that require review by the Commission.

Surrounding land uses and zoning are as follows:

North: Paper Company; M-2

South: Vacant; M-2 East: Vacant; M-2 West: Vacant; M-2

The project is exempt from environmental review pursuant to Section 15115 of CEQA. The plans submitted by the applicant do not appear to meet the 50 percent shading requirement of the zoning ordinance. A land-scaping plan, demonstrating the shading of the parking lot will be required upon submittal of building permit applications.

RECOMMENDATION

The Parcel Map Advisory Agency (Planning Director and City Engineer), based upon review by the Subdivision Review Committee, recommends approval of the tenta property to the following conditions:

- 1. The applicant shall provide standard subdivision improvements along North C Street, North D Street, Dos Rios Boulevard, North B Street and North lith Street pursuant to Section 40.811 of the Subdivision Ordinance prior to filing the final map.
- 2. The applicant shall prepare a sewer and drainage study (May require offsite extensions and oversizing) for the review and approval of the City Engineer prior to filing the final map.
- 3. The applicant shall submit a right-of-way study for the review and approval of the City Engineer.
- 4. The applicant shall provide for a 12-foot minimum lane on the west side of North 11th Street and the north side of North D Street.
- 5. Bonds, private contract and engineering fees required prior to filing the final map.
- 6. Streets and alleys not shown to be constructed must be abandoned prior to filing the final map.
- 7. The applicant shall retain all existing trees on the site.

This can be accomplished by adopting the attached tentative map resolution.

RESOLUTION ADOPTING FINDINGS OF FACT, APPROVING A REQUEST FOR TENTATIVE MAP FOR DOS RIOS BUSINESS PARK (APN: 001-121-01, 02, 03) (P-9388)

WHEREAS, the Parcel Map Advisory Agency has submitted to the City Council its report and recommendations concerning the Tentative Map for Dos Rios Business Park, located at the northeast corner of Dos Rios Avenue and North B Street (hereinafter referred to as the proposed subdivision).

WHEREAS, the Council of the City of Sacramento, based on testimony submitted at public hearing(s) conducted on June 9, 1981, hereby finds and determines as follows:

- A. The proposed subdivision, together with the provisions for its design and improvement, is consistent with the City General Plan and the Industrial Park Community Plan in that the plans designate the subject site for industrial uses.
- B. The site is physically suitable for the type and proposed density of development in that the subject site is flat with no significant erosional, soil expansion, or other similar problems.
- C. The design of the subdivision or proposed improvements are not likely to cause substantial environmental damage and will not substantially and avoidably injure fish, wildlife, or their habitat. The proposed project has been reviewed and assessed by the Environmental Coordinator, who has determined that the proposed project will not cause individual or cumulative adverse effects on the natural and social-physical environment or substantially and avoidably injure fish, wildlife, or their habitat pursuant to CEQA, Section 15115.
- D. The design of the subdivision or the type of improvements are not likely to cause serious public health problems in that community water and sewer systems exist at the site. The site is not within an established floodplain or over a known seismic fault.
- The design of the subdivision or the type of improvements will not conflict with easements acquired by the public for access through, or use of, the property within the proposed subdivision, in that there are no access easements for use by the public at large on the subject site.

- F. The discharge of waste from the proposed subdivision into the community sewer system servicing the proposed subdivision will not result in or add to a violation of the waste discharge requirements applicable to said sewer system which were prescribed by the California Regional Water Quality Control Board, Central Valley Region, in that the existing City of Sacramento treatment plants have a design capacity of 75 mgd and that actual treated discharge averages 56 mgd. The discharge from the proposed project will not create a condition exceeding the design capacity.
- G. The design of the proposed subdivision provides, to the extent feasible, for future passive or natural heating or cooling opportunities in the proposed subdivision, taking into consideration the local climate, the contour and configuration of the parcel to be divided, and such other design and improvement requirements applicable to the proposed subdivision.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Sacramento as follows:

The Tentative Map be approved subject to the following conditions:

- 1. The applicant shall provide standard subdivision improvements along North C Street, North D Street, Dos Rios Boulevard, North B Street, and North llth Street pursuant to Section 40.811 of the Subdivision Ordinance prior to filing the final map.
- 2. The applicant shall prepare a sewer and drainage study (may require offsite extensions and oversizing) for the review and approval of the City Engineer prior to filing the final map.
- 3. The applicant shall submit a right-of-way study for the review and approval of the City Engineer.
- 4. The applicant shall provide a 12-foot minimum lane on the west side of North 11th Street and the north side of North D Street.
- 5. Bonds, private contract, and engineering fees required prior to filing the final map.


