Staff has reviewed the proposed project, and approves it with the following conditions of approval:

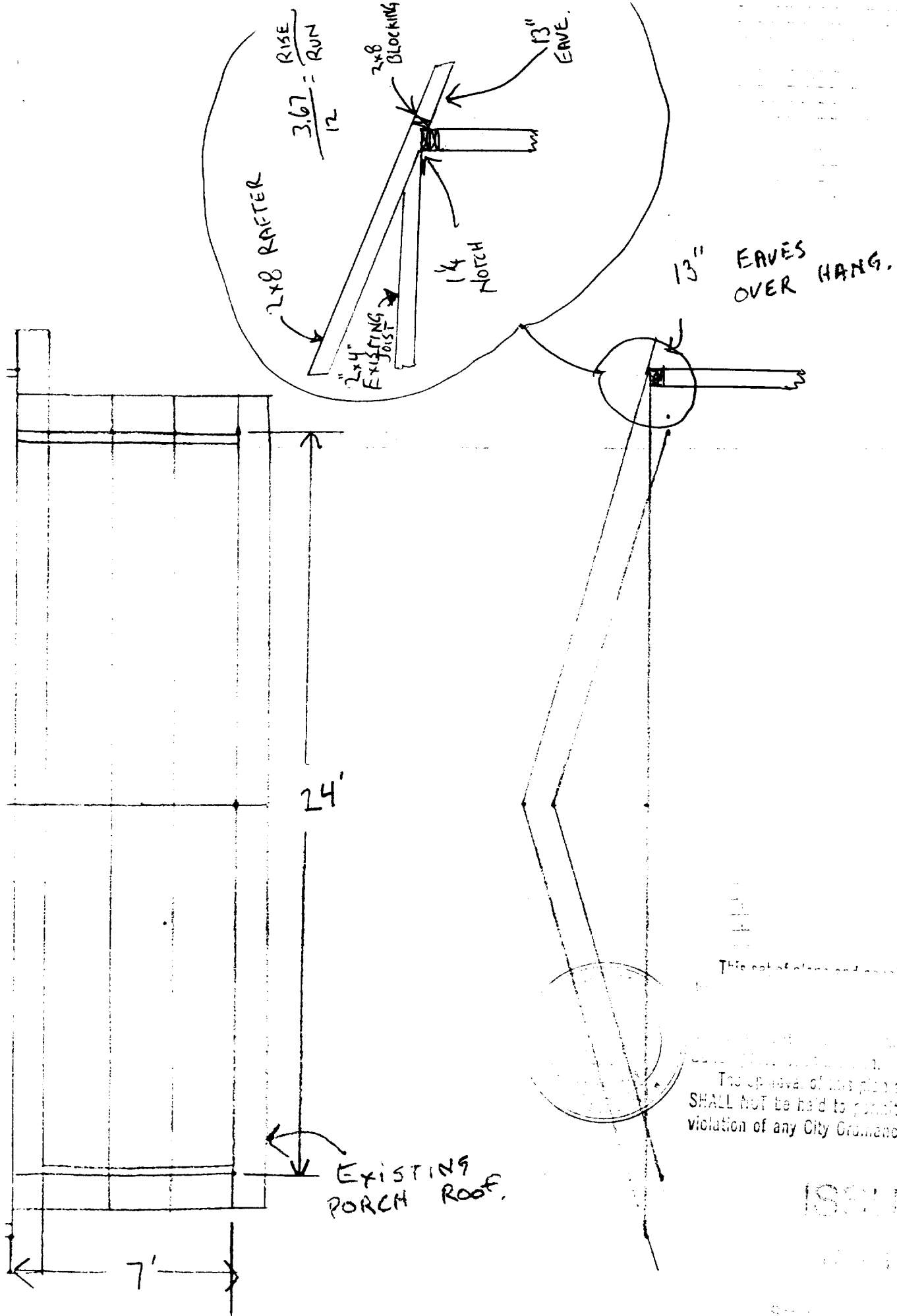
1. Roofing shall be 25-year laminated dimensional composition shingle.

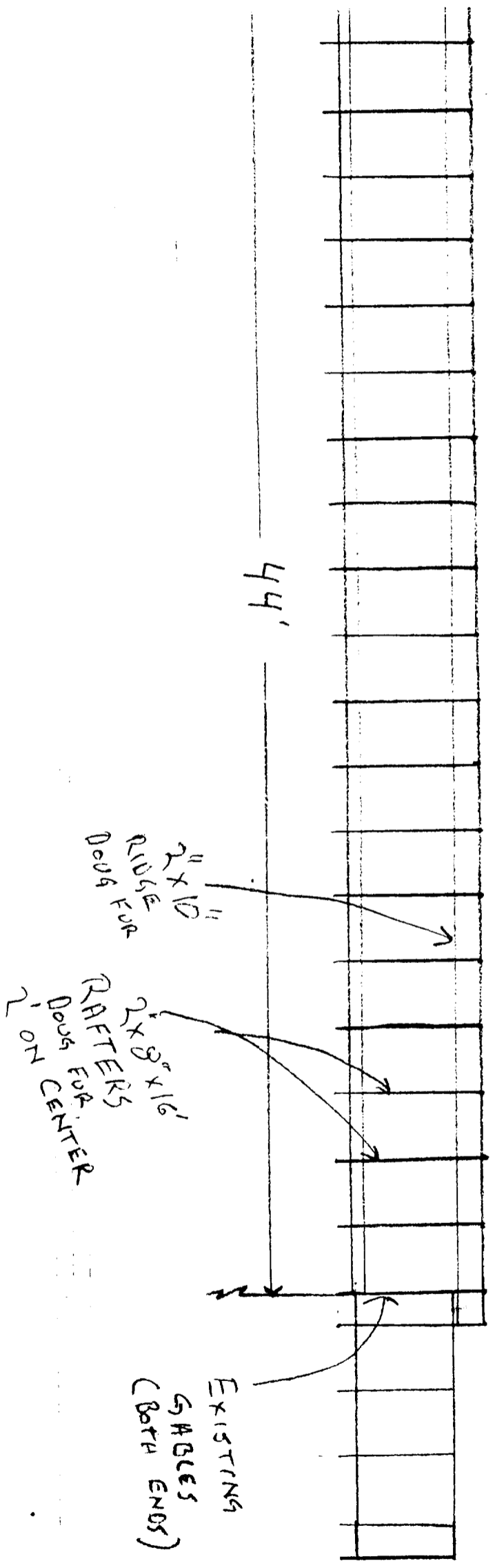
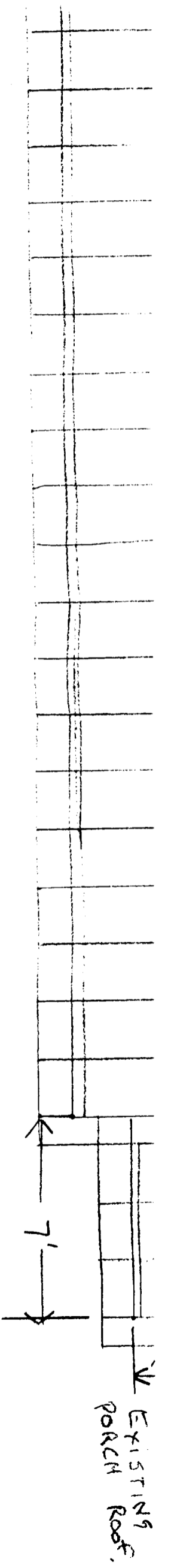

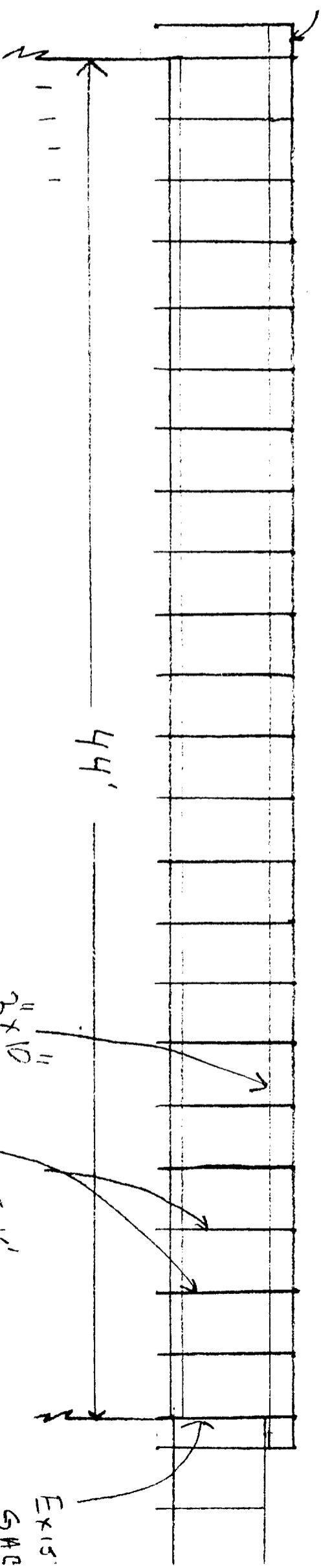
