SUBJECT: City Participation in County CDBG Street Improvement
Project - Resolution Appropriating \$15,000 from the
General Revenue Sharing Fund

SUMMARY:

On November 3, 1980 the Budget and Finance Committee approved staff's report recommending City participation in Phase II of a County CDBG Street Improvement project in the Fruitridge panhandle between 14th Avenue and Fruitridge Road at an estimated cost of \$15,000. The report was then forwarded to the City Council and approved at their November 12, 1980 meeting. The City Engineer recommends that the attached resolution appropriating \$15,000 from the General Revenue Sharing fund be approved.

RESOLUTION AMENDING THE CITY BUDGET FOR F.Y.
1980/81 FOR PHASE II OF THE COUNTY CDBG STREET
IMPROVEMENT PROJECT

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The City of Sacramento is participating in Phase II of a County CDBG Street Improvement project in the Fruitridge panhandle between 14th Avenue and Fruitridge Road at an estimated cost of \$15,000.
2. The City Budget for Fiscal Year 1980/81 is hereby amended by appropriating \$15,000 from the unappropriated General Revenue Sharing Fund Balance (2-11) to the County CDBG Street Improvement Project (2-11-2600-2411-4820) for the purpose stated in Paragraph 1 above.
