BACKGROUND INFORMATION

The Council awarded a contract to Teichert Construction on August 21st, 1979 for constructing concrete curbs, gutters and sidewalks, asphaltic concrete pavement, storm sewers, drainage facilities, sanitary sewers, sewer services, reconstruct water distribution system, reset mail bixes and a street lighting system complete in the above named Assessment District. At the time of signing the contract, the completion date was scheduled for September 3rd, 1980, however, the work will not be finished by that date due to a delay in starting construction because of inclement weather.
