SUBJECT: PROPOSED RETITLING OF FIRE PREVENTION TECHNICIAN
TRAINEE, I, AND II CLASSIFICATIONS

SUMMARY

This report recommends retitling the classifications of Fire Prevention Technician Trainee, I, and II to Fire Prevention Officer Trainee, I, and II.

BACKGROUND AND ANALYSIS

In this job series, the term "Technician" is being changed due to its implication of dealing with a specific, highly scientific body of knowledge. Instead, the term "Officer" has been identified as more appropriate as it emphasizes the nature of the role of these classifications, which is to enforce fire prevention codes and regulations. The term "Officer" offers a similarity in nomenclature to other City of Sacramento classification titles such as Nuisance Abatement Officer, Animal Control Officer, and Parking Enforcement Officer.

There is no financial impact since this only involves title changes.

None.




RECOMMENDATION
