SUMMARY

Attached is a tabulation of sealed proposals received by the City Clerk for furnishing material in accordance with specifications adopted by the City Council and recommendation of bid award for the following:

Strapping Wire For Waste Baler to be used by Solid Waste Division

RECOMMENDATION

It is recommended that, in the City's best interest, the City Council accept the lowest responsible bid submitted per Chapter 57 of the Sacramento City Code, as follows:

Authorization is being requested to enter into a contract in an amount not to exceed \$170,000.00 per year, which more closely reflects the actual amount to be expended each year of this potential 3 year contract.

### BACKGROUND

Specifications were adopted by the City Council on January 14, 1992 and bids were called for by the City Clerk on February 5, 1992.

### FINANCIAL CONSIDERATIONS

Sufficient funds have been budgeted in the Solid Waste Landfill 1991/92 and 1992/93 operating budget for this strapping wire required for the new waste baler.


### POLICY CONSIDERATIONS

### MBE/WBE


