Diane Balter, Deputy City Attorney, explained to the Committee that this ordinance will allow our City Code to conform with State law, as the State has preempted the City. Pope moved to approve the ordinance amending Sections 24.9 through 24.15 of Chapter 24 of the Sacramento City Code relating to the furnishing of tobacco products to minors. Robie seconded the motion and it was unanimously approved. This will now go before the full Council.

Robie asked how many fines are actually levied for this type of violation. Reggie Young, Deputy Director of Public Works, said that 12-15 citations are given per year, more in some areas than others. He said that violators are generally business people who take a chance and, if cited and fined, consider that part of the cost of doing business. Pope moved to approve this ordinance, Robie seconded the motion, and it was unanimously approved. This will now go before full Council.





The Committee members expressed the importance of this ordinance, as they all had problems in their districts with this. Kastanis moved to approve this ordinance, Robie seconded the motion, and it was unanimously approved. This will now go before the full Council.

There was a short discussion regarding the protesters around the area of 11th and K Streets, especially the trumpet player and those repeatedly ringing doorbells in the lobby. Shore said the City should define the limits of "free speech." Diane Balter, Deputy City Attorney, stated that this is very difficult to pin down. Shore said there must be some limit when free speech infringes on businesses.
