SUBJECT: ARREST AND CITATION AUTHORITY FOR REVENUE DIVISION
EMPLOYEES

SUMMARY

This report recommends a change to Resolution No. 87-001 which lists the names of employees in the Revenue Division having been granted arrest and citation authority.

BACKGROUND

City Council Resolution 87-001 grants limited arrest and citation authority for certain Department of Finance, Revenue Division employees. The arrest and citation authority permits the employees to enforce collections of City taxes, fees and charges.




It is recommended that the City Council adopt the attached resolution which deletes Louis A. Miller from Section 2 of Resolution No. 87-001.
