**SUBJECT: ANNEXATION OF A PORTION OF 39TH STREET, R STREET, AND
40TH STREET TO THE UC MEDICAL CENTER RESIDENTIAL PERMIT
PARKING AREA**

SUMMARY

This report recommends annexation of 39th street from P street to R Street, R Street from 39th to 40th Street, and 40th Street from P Street to R Street into the UC Medical Center residential Permit parking area.

BACKGROUND

The growth of the UC Medical Center has increased the demand for parking. Parking congestion is increasing on some residential streets adjacent to the permit parking area and residents are having difficulty parking near their homes. The residents along these street segments have submitted a petition, representing 81% of the residential units, requesting to be annexed into the UC Medical Center Residential Permit Parking Area and regulated with two-hour except with "B" permit parking time limits.

FINANCIAL DATA

The cost to annex these street segments is \$900 for the installation of regulatory signing. Funds are available in the Traffic Signs and Markings Operational Budget (101-310-3122-4471).

POLICY CONSIDERATIONS

This recommendation is consistent with Sacramento City Code 25.186, annexing of residential streets to residential permit parking areas.



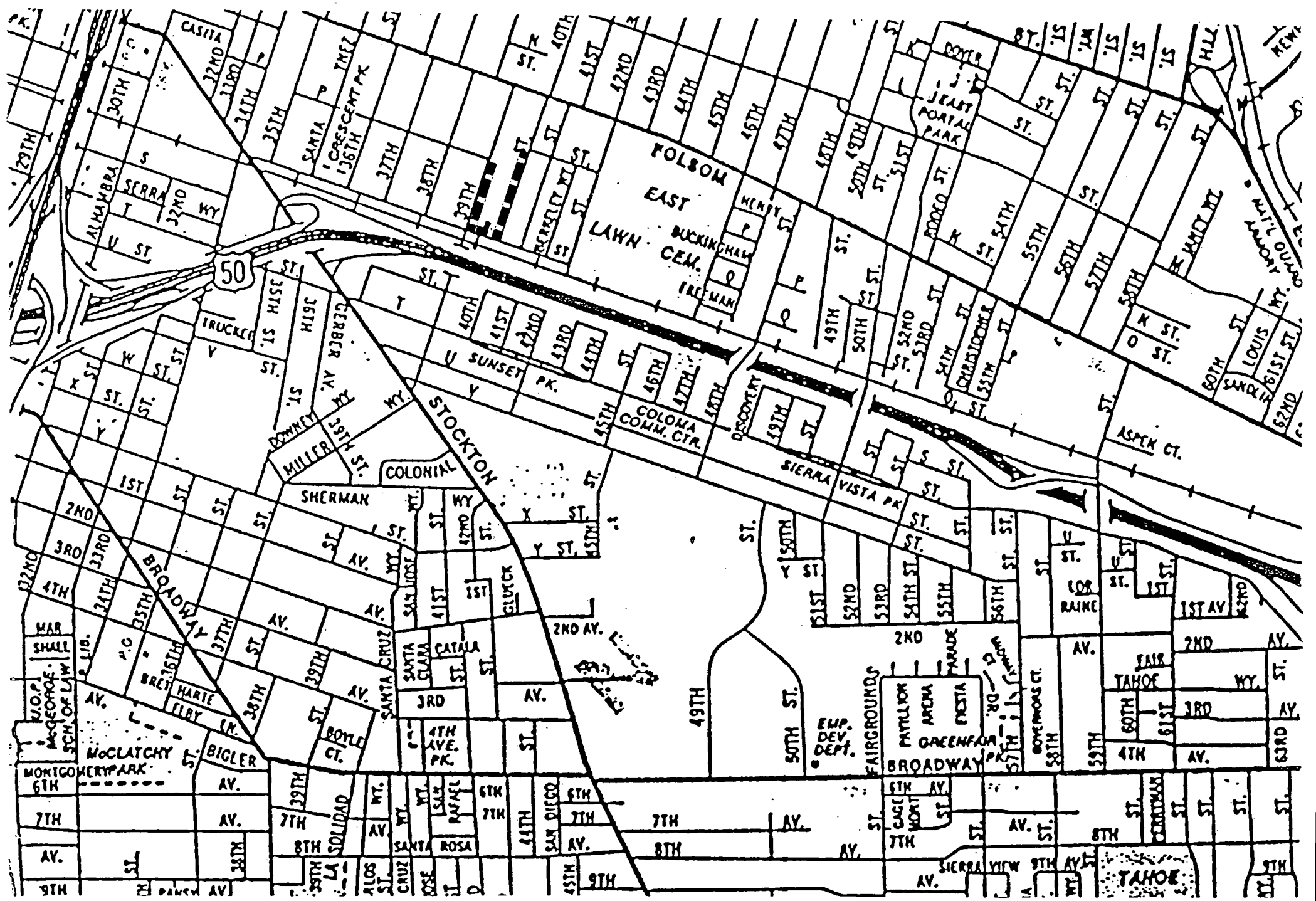
