**SUBJECT: AGREEMENT BETWEEN THE CALIFORNIA DEPARTMENT OF CORRECTIONS
AND THE CITY OF SACRAMENTO REGARDING PAROLEE POPULATION**

SUMMARY

On July 28, 1981, the Police Department submitted a report to the City Council advising you that the California Department of Corrections had proposed the establishment of a Community Correctional Center in Sacramento. The Police Department requested that the City Council submit a letter to the California Department of Corrections opposing the establishment of the Community Correctional Center in Sacramento. Subsequently, the City Council requested the Police Department to meet with the California Department of Corrections and the California Youth Authority to obtain a written agreement which would limit the number of parolees in Sacramento.

This report outlines the verbal agreement reached between the City of Sacramento and the California Department of Corrections regarding the release of parolees in Sacramento.

BACKGROUND INFORMATION

On October 26, 1981, Howard Miller, Deputy Director of the California Department of Corrections, was contacted in regards to a written Memorandum of Understanding in connection with the steps taken to limit the number of parolees released to Sacramento County. A series of meetings between the Department of Corrections and City representatives have recently been held. Verbal commitments had been obtained from the Department of Corrections on steps they would implement to provide information regarding parolee population and to restrict the number of parolees released to Sacramento to an amount proportionate to the number committed annually by Sacramento County. During these negotiations, the issue of community correctional centers was deferred at the mutual request of all parties as it was not pertinent to reducing the number of parolees from other counties that were released or transferred to Sacramento.

Mr. Miller advised the Department that the verbal agreement reached in discussions with the City Attorney and Captain Harry Hogan were being honored and had been implemented. Because of this showing of good faith, he did not feel that it was

necessary to do a written Memorandum of Understanding. He also pointed out that a written agreement had already been submitted in which the Department of Corrections agreed to adopt a goal of limiting the parolee releases to 10% over the annual County commitment rate.

During negotiations held between City representatives and the Department of Corrections, the following steps were verbally agreed to:

1. All parolees being released to this area will be carefully screened and photographs and record information will be provided to local law enforcement.
2. Parolees released to another county and desiring to transfer to Sacramento County will have to have a verifiable parole program prior to transfer or they will not be accepted for parole to Sacramento County.
3. Local law enforcement agencies will be provided parolee computer information on a monthly basis which will include the name of the parolee, California Department of Corrections I.D. number, Criminal Identification and Investigation number, County of commitment, Date of Birth, Date transferred to parole, Tentative discharge date, Parole Unit assignment, Institution released from, and County of residence.

In addition to the above, similar information will also be provided on those parolees transferred into Sacramento County from other counties and those transferred out of the County.

4. Quarterly monitoring reports on parolee cases referred to Sacramento County will also be provided to the Sacramento Police Department.

On Thursday, October 29, 1981, at 3:00 p.m., Jack Allen, District Parole Administrator, met with Chief Kearns and Captain Hogan and advised us that the Department of Corrections had selected the Volunteers of America, 404 U Street and Sojourner House, 1921 - 28th Street, as the vendors for prospective community correctional centers. These organizations will be looking at several sites for the placement of the centers. No information of the exact location of possible sites was available.

RECOMMENDATION


