SUBJECT: Resolutions to Transfer Funds and Prohibit Parking for

Pilot Street Cleaning Program in Oak Park.

#### SUMMARY

This report recommends prohibiting parking on both sides of the street one morning per week to aid street cleaning in an area bounded by 34th St, 3rd Ave, Broadway and 5th Ave in Oak Park. (See attached map).

#### BACKGROUND

In January the Council requested a report on a pilot program of prohibiting parking to facilitate street cleaning in Oak Park. In July, staff was advised of the specific area where this program was desired.

An analysis was made to determine if it was practical to prohibit parking on one side of the street one day and the other side on another day each week. It was determined, since this is such a small portion of a very large service area, the street cleaning costs would be out of proportion to the area of benefit. Therefore, early in August it was decided that parking would be prohibited on both sides of all streets one morning per week. This will require that all cars will have to park off-street or outside of the area for about four hours per week.

While the above plan avoids additional street cleaning costs, it is not a plan that could be used in a larger area with inadequate off-street parking.

#### FINANCIAL DATA

The annual operating cost for enforcement is estimated to be about \$1400. The cost for the signs is \$2200, and the operating cost to post the signs is \$1700. The operating costs can be absorbed in the operating budgets, but a resolution is attached to transfer funds for the cost of the signs.

It is recommended that the attached resolutions establishing the parking regulations and transferring the funds be adopted.


