Subject: Minority/Women Business Enterprise Demographic Data

#### SUMMARY

On October 25, 1988, the City Council approved the first quarter's progress report for the City's Minority/Women Business Enterprise (M/WBE) Program. This document contained an ordinance which would authorize the City to collect business demographic information from City business licensees. The ordinance was passed for publication on October 25th and it is requested that Council approve the ordinance at its November 1, 1988 meeting.

### ANALYSIS

The attached ordinance revises Chapter 23 of the City Code to permit staff to voluntarily collect business demographic information as a part of the business license application/renewal process. This data will be used to establish <u>local</u> business demographic data. The ordinance directs staff to prepare a resolution which would establish what information would be collected and to return this resolution to the Council for approval within ninety days.

### RECOMMENDATION

It is recommended that the City Council approve the attached ordinance which will permit staff to collect business demographic data.

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

AN ORDINANCE AMENDING SECTION 23.301
OF THE SACRAMENTO CITY CODE
RELATING TO THE GATHERING OF
BUSINESS OWNER DEMOGRAPHIC INFORMATION

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

### SECTION 1.

Section 23.301 of the Sacramento City Code is hereby amended to read as follows:

Section 23.301 Application for First Certificate.

A person making application for the first certificate to be issued hereunder, or for a newly established business or for a new ownership of a previously established business shall furnish to the administrator a sworn statement, on a form by the Administrator, setting forth the following information:

- (a) The exact nature or kind of business for which a certificate is requested;
- (b) The place where such business is to be carried on, and if the same is not to be carried on at any permanent place of business, the places of residence of the owners of same;
- (c) The fictitious name or names under which the business will be operated, if any, and the name of the person to whom the certificate is issued;
- (d) Such further information as the Administrator may deem necessary to enable him to issue the certificate applied for. (Ordinance 84-401, Section 2).

The Administrator may also collect demographic information from each applicant. This data shall be obtained on a voluntary basis. The nature of the demographic information to be requested from applicants

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

### SECTION 1.

Section 23.301 of the Sacramento City Code is hereby amended to read as follows:

Section 23.301 Application for First Certificate.

A person making application for the first certificate to be issued hereunder, or for a newly established business or for a new ownership of a previously established business shall furnish to the administrator a sworn statement, on a form by the Administrator, setting forth the following information:
