Cooperative Purchase Agreement: Replacement Loaders

Recommendation: Pass a **Motion:** 1) approving the use of the Sourcewell cooperative purchase agreement with John Deere Construction Retail Sales (Contract No. 011723-JDC) for the purchase of five replacement loaders and one replacement excavator not to exceed \$844,579; and 2) authorizing the City Manager or the City Manager’s designee to take any necessary actions to complete the purchases specified above.

Description/Analysis

Issue Detail: The Department of Public Works, Fleet Management Division, has a customer requirement to purchase five replacement John Deere Loaders for the Department of Public Works. These include two for the Pavement Maintenance Section of the Maintenance Division to replace units 10594 and 10198, one for the Illegal Dumping Collection Section of the Recycling and Solid Waste Division (RSW) to replace unit 12131, and two for the Seasonal and Appointment Collection Section of RSW to replace units 12135 and 12133. The loaders will be used to assist with leveling and smoothing surfaces for pavement maintenance and picking up debris (both illegally dumped and scheduled service pickups as part of residential waste services).

Policy Considerations: The recommendations in this report are in accordance with City Code Chapter 3.56, which requires City Council approval of actions of \$250,000 or more and which provides for the use of cooperative purchase agreements without competitive bidding (Section 3.56.240).

Economic Impacts: None.

Environmental Considerations:

California Environmental Quality Act (CEQA): No environmental review is necessary because the recommendations in this report involve the purchase of vehicles and are not considered to be a project in accordance with Section 15378(b)(2) of the CEQA guidelines.

Sustainability: The recommended purchases are consistent with the updated Fleet Sustainability Policy, adopted by City Council on December 12, 2017 (Resolution No. 2017-0478) and California Air Resource Board (CARB) regulations as there is no comparable zero emission model available for replacement.

Commission/Committee Action: None.

Rationale for Recommendation: After reviewing the available purchase options, the Fleet Management Division has determined that the Sourcewell cooperative purchase agreement with John Deere Construction Retail Sales represents the most advantageous purchasing strategy. The contract was competitively bid nationally, and Sourcewell receives greater discounts from the manufacturer due to a higher purchase volume than the City would receive if issuing its own bid.

In an ongoing effort to maximize cost savings and staff resources, many government agencies share contracting efforts through cooperative purchasing. This procurement method increases pricing competitiveness and lowers operating costs through volume buying. When comparing the administrative costs of procurement, staff considers product research, source selection, specifications, advertising, staff reports, awarding, protest, and administration of the contract.

The City has used both regional and national cooperative purchase agreements to complement its own contracting initiatives. Cooperative purchasing enables City departments to evaluate a broader range of contracting opportunities and to share resources with other jurisdictions. Cooperative purchasing also leverages internal and external resources to maximize cost savings opportunities for the City.

Financial Considerations: The recommended purchase, in a total amount not to exceed \$844,579, will be made from the Department of Public Works Fiscal Year (FY) 2024/25 operating budget (Fleet Fund, Fund 6501) and will be charged to the Department of Public Works, Pavement Maintenance (I06152125, Fund 2002), Illegal Dumping Collection (I06150025, Fund 1001), and Seasonal and Appointment Collection (I06147025, Fund 6007). Sufficient funding exists in the Department of Public Works FY2024/25 operating budget and the Department of Public Works Fleet Projects (I06152125, I06150025, and I06147025) to support the recommended purchases.

Local Business Enterprise (LBE): John Deere Construction Retail Services is not an LBE. The minimum LBE participation requirement is waived for the City's use of cooperative purchase agreements that have been competitively bid, evaluated, and awarded by other governmental agencies that may or may not have similar LBE programs.

ADDITIONAL TERMS AND CONDITIONS COOPERATIVE PURCHASE AGREEMENT

WHEREAS, John Deere Construction Retail Sales a division of John Deere Shared Services, Inc. ("Vendor") and Sourcewell entered into **Sourcewell Contract # 011723-JDC** for the procurement of Heavy Construction Equipment with Related Accessories, Attachments and Supplies ("Sourcewell Contract");

WHEREAS, Pape Group Incorporated ("Pape" or "Dealer") is an approved dealer for Vendor, and has agreed to be bound by the terms and conditions of the Sourcewell Contract;

WHEREAS, Sourcewell Members may agree to "additional terms and conditions" through the Sourcewell Contract; and

WHEREAS, the City of Sacramento ("City") is a Sourcewell Member, and wishes to purchase equipment manufactured by Vendor pursuant to the terms of the Sourcewell Contract, with these Additional Terms.

NOW THEREFORE, Pape and the City agree as follows:

1. **Purchase of Equipment at Quoted Prices.** The City agrees to purchase the Equipment set forth in the attached Price Information (Attachment 1 hereto) from Pape, pursuant to the terms and conditions of the Sourcewell Contract. The terms of the Sourcewell Contract shall apply to this purchase and shall control over any contrary terms included in the Revised Price Quotation.
2. **Purchase via Purchase Order.** Pape agrees that the Equipment identified in the Price Information shall be delivered to the City, as ordered via a subsequently issued Purchase Order, through the Sourcewell Contract expiration date.
3. **Indemnity.** Pape shall defend, hold harmless, and indemnify City, its officers, and employees, and each and every one of them, from and against all actions, damages, costs, liabilities, claims, demands, losses, judgments, penalties, and expenses of every type and description, whether arising from the purchase, delivery or use of the Equipment set forth in the attached Revised Price Quotation, including any fees and costs reasonably incurred by City's staff attorneys or outside attorneys and any fees and expenses incurred in enforcing this provision (hereafter collectively referred to as "Liabilities"), including Liabilities for personal injury or death, damage to personal, real, or intellectual property, damage to the environment, contractual or other economic damages, or regulatory penalties, arising out of or in any way connected with performance of or failure to perform by Pape, any subcontractor (including lower-tier subcontractors) or agent of Pape, their respective officers and employees, and anyone else for whose acts of omissions any of them may be liable, whether or not the Liabilities (i) are caused in part by a party indemnified hereunder, or (ii) are litigated, settled, or reduced to judgment; provided that the foregoing indemnity does not apply to liability for damages for death or bodily injury to persons, injury to property, or other loss, damage, or expense, to the extent arising from the active negligence or willful misconduct of, or defects in design furnished by, City, its agents, servants, or independent contractors who are directly responsible to City, except when such agents, servants, or independent contractors are under the supervision and control of Contractor or any subcontractor (including lower-tier subcontractors) or agent of Pape.
4. **Insurance.** Contractor shall, at its sole cost and expense, maintain the level of insurance coverage described in Sections G.6.21 – G.6.26 of the Sourcewell Contract. City shall have all of the rights as Sourcewell has under the Sourcewell Agreement, including those specified in Sections G.6.21 – G.6.26. Pape shall have the same obligations as Vendor under the Sourcewell Contract, including those specified in Sections G.6.21 – G.6.26.
5. **Authority.** Pape warrants and represents that the person or persons executing this document on behalf of Pape has or have been duly authorized by Pape and Vendor to sign these Additional Terms and bind Pape to the terms hereof.
6. **Venue and Jurisdiction.** The relationship and agreement between the parties shall be construed and enforced in accordance with the laws of the State of California, except that the rule of interpretation in California Civil Code section 1654 will not apply. Venue of any litigation will lie exclusively in the state trial court or Federal District Court located in Sacramento County in the State of California, and the parties consent to jurisdiction over their persons and over the subject matter of any such litigation in such courts, and consent to service of process issued by such courts.
7. **Except as specifically modified herein, all terms and conditions of the Sourcewell Contract shall remain in full force and effect, and Contractor shall perform all of the services, duties, obligations, and conditions required under the Agreement, as supplemented and modified by these Additional Terms.**
