BACKGROUND

Scope of Work

Staff is proposing a scope of work for a performance audit of the Community Development Department related to the current building permit, permit approval, and fee collection processes as well as staffing and funding levels.

The Performance Audit would include a review of the following:

- Review of current building permitting processes to assure they are in accordance with applicable rules and regulations.
- To assess the current permit approval process to identify gaps in controls and appropriate levels of review for approval.
- To evaluate the current fee collection process to identify the key controls in the fee collection process and assess whether the controls are properly designed to prevent, detect or correct irregularities on a timely basis.
- Evaluation of staffing and funding levels to determine if they are adequate to carry out the duties and responsibilities of the organization.

Request for Qualifications

Staff is requesting direction to issue a Request for Qualifications (RFQ) for consultant services to conduct the performance audit. A RFQ focuses on the experience and qualifications of a firm as well as the proposed approach to conducting the performance audit.

If the Committee approves the issuance of a RFQ, staff will assemble a Selection Panel consisting of internal staff and at least one external public agency representative (e.g. Finance Director from another city) to review the proposals. Step one of the process will consist of a review of the experience, qualifications, and approach of interested firms. Step two would include interviews with the top ranked firms. Staff would bring forward a recommended consultant and along with funding options to the Audit Committee in January 2010.
