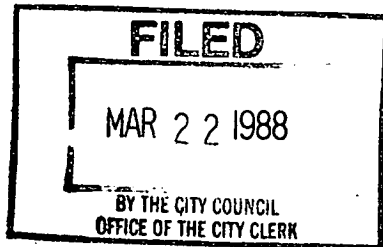
WHEREAS, Tom Fay and Janie Steele own and operate "Out of The West" a local publishing company engaged in promoting Sacramento and California products; and
