Award and Budgetary Adjustments: Marysville Boulevard Vision Zero Quick Build (Phase 1) Project (T15216300)

BACKGROUND

- A. The Marysville Boulevard Vision Zero Safety Project (T15216300) is located on Marysville Boulevard between Arcade Boulevard and North Avenue. The project's limits were identified in the *Vision Zero Top 5 Corridors Plan* as one of the top 5 corridors in the City with the highest number of fatal and serious crashes. Improvements identified for the Marysville Boulevard corridor include a road diet, bicycle lane gap closures, upgrading existing bike lanes to protected bike lanes, sidewalk improvements, pavement repair, upgrading existing unsignalized intersections to controlled crossings, modifying existing traffic signals, a new pedestrian signal, and signing and striping.
- B. While the long-term corridor-wide improvements on Marysville Boulevard are being developed, the City is also seeking construction funding to implement the mile-long corridor project. In 2025, the City established a "Phase 1" Quick Build Safety Program (T15255300) to implement interim Phase 1 safety measures that can be deployed sooner in more complex, high-priority locations while corridor-wide improvements are being designed.
- C. The Marysville Boulevard Vision Zero Safety Quick Build (Phase 1) project is on Marysville Boulevard, from Los Robles Boulevard to Harris Avenue. Phase 1 is a 0.5-mile segment of the overall corridor project which includes the construction of a road diet, reducing travel lanes from four-to-two lanes; adds protected and Class II buffered bike lanes; adds limited on-street parking; adds high visibility pedestrian crosswalks at the intersections at Roanoke Avenue and Grand Avenue; and includes minor traffic signal modifications, signing, and pavement slurry seal.
- D. Plans and Specifications for the Marysville Boulevard Vision Zero Safety Quick Build (Phase 1) Project were completed.
- E. The Project was advertised for construction, and a total of six bids were received on November 19, 2025. The Engineer's Estimate was \$790,000. The bidders met all required bid conditions. The results of the bids are summarized below:

- F. Staff recommends awarding the construction contract to the lowest responsive and responsible bidder, Martin General Engineering, Inc.
- G. The budgetary adjustments proposed with this City Council action will allow the Marysville Boulevard Vision Zero Safety Quick Build (Phase 1) construction to move forward on schedule.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

SECTION 1.

Plans and Specifications for the Marysville Boulevard Vision Zero Quick Build (Phase 1) Project are approved.

SECTION 2.

The City Manager or designee is authorized to increase the expenditure budget of the Marysville Boulevard Vision Zero Safety Project (T15216300) by transferring \$1,000,000 (Major Street Construction, Fund 2007) and \$228,356 (Road Maintenance and Rehabilitation, Fund 2036) from the Quick-Build Safety Program (T15255300) to fund the completion of the Marysville Boulevard Vision Zero Quick Build (Phase 1) Project.

SECTION 3.

The construction contract for the Marysville Boulevard Vision Zero Quick Build (Phase 1) Project is awarded to Martin General Engineering, Inc. in an amount not-to-exceed \$820,436.

SECTION 4.

The City Manager or designee is authorized to execute the construction contract for the Marysville Boulevard Vision Zero Quick Build (Phase 1) Project to Martin General Engineering, Inc.
