1. PARTIES. The parties to this agreement are the County of Sacramento, referred to herein as the "County", and the City of Sacramento, referred to as the "City".

2. PURPOSE. The purpose of this agreement is to provide for the imprisonment of city prisoners in the county jail in accordance with the provisions of Government Code Section 36903.

3. TERM. The term of the agreement shall be three years commencing on the expiration date of the previous contract (December 20, 1979) providing that the agreement may be cancelled or modified by either party after thirty (30) days written notice thereof to the other party.

4. CARE OF PRISONERS. City prisoners imprisoned in the county jail pursuant to this agreement shall be cared for in accordance with the same standards and requirements as are applicable to county prisoners.

5. RATE. The amount which shall be paid to the county by the city for each city prisoner imprisoned in the county jail shall be computed at the rate entered below for each day or part thereof during which a city prisoner is imprisoned in the county jail.

The parties agree to comply with the terms of this agreement.

RESOLUTION AUTHORIZING CITY MANAGER TO EXECUTE
CONTRACT WITH COUNTY OF SACRAMENTO FOR HOUSING
OF CITY PRISONERS

WHEREAS, the provisions of Section 36903 of the Government Code provides that imprisonment for violation of a City ordinance in the County jail shall be an expense charged against the City; and

WHEREAS, the City and County of Sacramento have negotiated a fixed rate of \$23.88 for reimbursement of expenses incurred by the County of Sacramento for the imprisonment of each City prisoner per day;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the City Manager is hereby authorized to execute that certain agreement with the County of Sacramento for the reimbursement of expenses relating to the imprisonment of City prisoners in the County jail at the rate of \$23.88 per prisoner per day.
