SUBJECT: Actuarial Contract

SUMMARY

The Administration, Investment and Fiscal Management Board appointed the firm of Towers, Perrin, Forster and Crosby as the Retirement System Actuary in September 1980. City Council approval is requested of designating the City Manager to enter into a contractual agreement with Towers, Perrin, Forster and Crosby.

BACKGROUND

Under the authority of City Charter Section 384, the Administration, Investment and Fiscal Management Board is required to use the services of an actuary to provide consultation and advice on the funding and administration of the Retirement System. The City is obligated to pay the costs of retirement system administration, including actuarial services. The attached contract, approved by the parties and the City Attorney's office, requires City Council approval before disbursement of funds for service can be effected.

FINANCIAL DATA

Contractual fees charged by Towers, Perrin, Forster and Crosby during FY 1980-81 fall within the amount specifically allocated to the Personnel Department budget for the year. The expense of future actuarial service charges will be made as a part of the department's budget requests. The FY80-81 charge is \$26,400.

RECOMMENDATION

It is recommended that the City Council approve the designation of the City Manager to enter into a contractual agreement for actuarial services with Towers, Perrin, Forster and Crosby.
