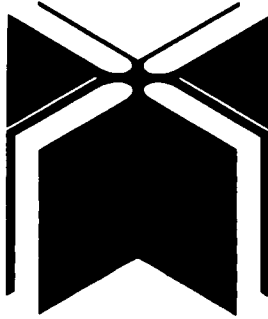

SUMMARY:

Sacramento Public Library has been awarded \$4,000 to serve Spanish speaking immigrant populations at the Colonial Heights Library.

COMMITTEE/COMMISSION ACTION:

STAFF RECOMMENDATION:

Approve the attached Resolution authorizing the City Manager to receive and expend grant funds.

BACKGROUND:

The California State Library has instituted a program with federal Library Services and Construction Act (LSCA) funds to support services for Spanish speaking immigrant populations. The demographics and population size of the Spanish speaking population utilizing Colonial Heights Library has resulted in an award of \$4,000 to purchase materials for use by this population. Award stipulates that only materials may be purchased with the grant funds and that the materials purchased must reside at the award library (Colonial Heights).

FINANCIAL CONSIDERATIONS:

Grant funds supplement materials budget of the Library and require no matching funds.

POLICY CONSIDERATIONS:






