SUMMARY:

Attached is a tabulation of sealed proposals received by the City Clerk for furnishing three-wheeled turf and police type vehicles in accordance with specifications adopted by the City Council.

BACKGROUND INFORMATION:

Formal Bid No. 776, which called for four (4) turf and two (2) police type vehicles was solicited by the City Council on January 29, 1985. Since the date of this requirement, Fleet Management has modified the specifications on two of the turf type vehicles to facilitate the functions of the user.

It has been determined that it would be in the City's best interest to purchase two (2) turf vehicles in lieu of four (4) and re-advertise on the other two at a later date. The vendor was advised and has agreed with our decision.

It is recommended that the City Council accept the lowest responsive and responsible proposal submitted as follows:
