**SUBJECT: PROPOSED PARKING TIME LIMITS - 16TH STREET FROM R TO S STREETS**

SUMMARY

This report recommends the addition of two (2) hour parking time limits on the west side of 16th Street from R to S Streets.

BACKGROUND

This block of 16th Street is currently unregulated and is congested with all-day parkers. A new office building, with ground floor retail on the 16th Street side, occupies the entire block. Businesses on this street segment have requested that parking be regulated with two (2) hour parking time limits to accommodate their customers' short-term parking needs. As additional businesses occupy the available frontage, two-hour parking regulations will provide short-term parking for conducting business.

FINANCIAL DATA

The cost to implement parking regulations on this street segment is \$200. Funds are available in the Traffic Signs and Markings Operational Budget (101-310-3122-4471).

POLICY CONSIDERATIONS

This recommendation is consistent with Sacramento City Code 25.109, City Council, which regulates parking time limits on streets designated by resolution.



It is recommended that the attached resolution be adopted to limit parking on the west side of 16th Street from R to S Streets to two (2) hour parking time limits.



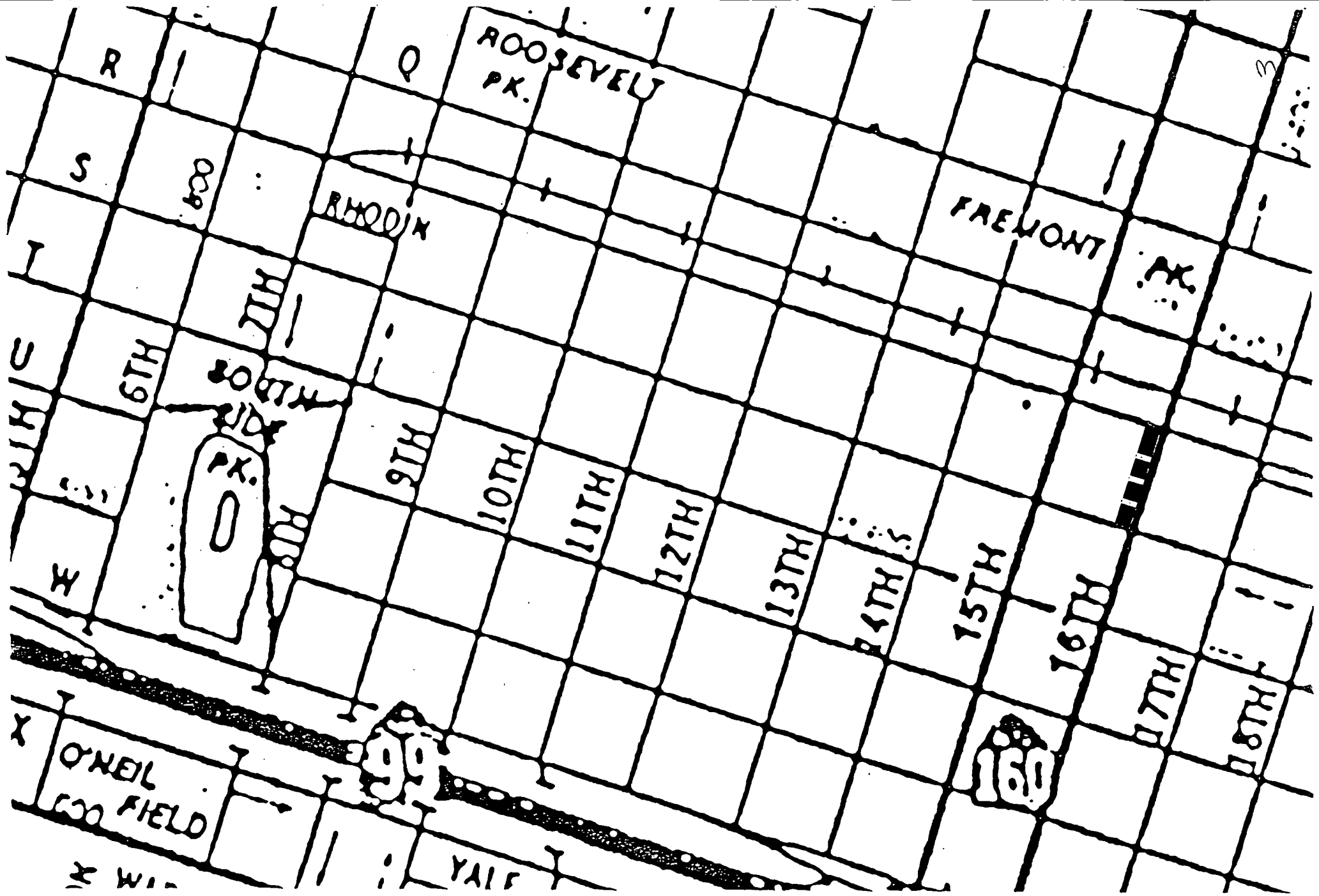

A RESOLUTION ESTABLISHING PARKING TIME LIMITS  
ON THE WEST SIDE OF 16TH STREET FROM R TO S STREETS

Be it resolved by the Council of the City of Sacramento:

Pursuant to Section 25.109 of the Sacramento City Code, when authorized signs have been placed by the Parking Manager giving notice thereof, no person shall stop, stand, or park any vehicle in a business district or on street designated by resolutions during the days and hours indicated on such signs for a period of time longer than specified on such signs.
