Acquisition of a 1.934 acre Park Node in Proposed Lake Crest SUBJECT:

Village Unit No. 5

## SUMMARY

Adoption of a Resolution to cover the acquisition costs of Lot C of the proposed Lake Crest Village Unit No. 5 as part of the Pocket Canal Parkway Plan.

### BACKGROUND INFORMATION

The 1979-80 Capital Improvement Budget allocated \$120,000.00 for the purchase of two park nodes within the Lake Crest Village Subdivisions. This figure includes the purchase price and sewer bonds presently on the property. The owner has agreed to sell the first of the two nodes indentified as Lot C of proposed Lake Crest Village Unit No. 5 for the appraised value of \$48,350.00 with the City assuming the existing sewer assessments and the cost of the upcoming street improvements at the time of the subdivision construction.

#### FINANCIAL DATA

The expenditure of \$49,350.00 to cover the acquisition and estimated closing costs to be expended from the Park Development Fund, Budget Number 2-44-2240-2196-4813.

#### RECOMMENDATION

It is recommended that the attached Resolution be adopted, authorizing the Director of Finance to expend the sum of \$49,350.00 for the acquisition and estimated closing costs of said Lot C.


