My Name is Elizabeth Shrum and I'm here to express my concern regarding water usage metering. As a homeowner, I know that I am responsible for my own usage. However, as a landlord, I believe that the tenants should be responsible for their own water usage. In Various cities of our State and in many other States, the water bill is in the occupant's name. Owners should not be responsible or have to baby sit our rentals to make sure water is not being wasted or left running and having to pay the consequences of negligence on the renter's part. I know at one time the City would put a lien against a home if the utility bill was continually left unpaid. I can see homeowners walking away if they cannot get enough rental income to cover the monthly expenses including the water. Do we really want to see another vacant repossessed house in our neighborhood? I don't. If renters don't have to pay, they won't care how much water they use or waste. The City could lose revenue by continuing to charge the owners who might be unable to pay. However, charging water usage to the occupants of the home will probably increase the revenue of the City plus decrease water usage or waste. Renters will more likely pay the water bill if they know they are responsible and that the water will be shut off for nonpayment.

I believe this is a major concern for homeowners who have rental income property. In my opinion, the changeover does not have to be so difficult if the City would send water bills using the same procedure as PG &E and SMUD. What is the City Council's response on this matter?
