SUBJECT: AGREEMENT: NOISE CONTROL ORDINANCE AND SMOKING
POLLUTION ORDINANCE ENFORCEMENT SERVICES.

SUMMARY

The County of Sacramento provides enforcement services for the City of Sacramento of Chapter 37 - Smoking Pollution Control and Chapter 66 - Noise Control of the Sacramento City Code. This report recommends that a professional services agreement be authorized with the County of Sacramento for \$50,000 for FY 1990-91 to provide these services. This report was heard by the Budget and Finance Committee on May 14, 1991. The Committee recommended approval of a one (1) year contract for FY 1990-91 and requested a report back on conforming with the County's ordinance and cost for the same level of service in-house.

BACKGROUND

The Environmental Health Division of the Environmental Management Department of the County of Sacramento has provided enforcement services to the City of Sacramento since the City's inception of the Smoking Pollution and Noise Control Ordinances in 1985. The City and County agree that it is in the best interest of the community due to the experience, expertise and available equipment of the County for the County to continue this provision of services.

FINANCIAL INFORMATION

A total of \$100,000 is currently appropriated in the Neighborhood Services professional services budget. The cost of the contract for FY 1990-91 is \$50,000. No additional appropriation of City funds is required.

POLICY CONSIDERATIONS

This contract is needed to enforce the provisions of Chapter 37 - Smoking Pollution Control and Chapter 66 - Noise Control of the Sacramento Code.




