SUBJECT: Authorization to Sell Surplus Property on
Morrison Avenue

BACKGROUND INFORMATION

The City acquired this parcel of land from the State of California as part of the Freeway Agreement for Interstate 880. The original use of this parcel was for street purposes to provide access to land-locked parcels bordering the Freeway. These parcels are now owned by properties fronting on Morrison Avenue making a street unnecessary at this time. The property on the east side of the City parcel has expressed interest in bidding for the parcel.

The minimum value of the property, \$69,500.00, was established by an independent appraiser.

FINANCIAL DATA

All proceeds from the sale will be deposited in the General Fund.

It is recommended that the attached Resolution authorizing the City Clerk to advertise for bids, with a bid date of December 1st, 1981, be adopted.

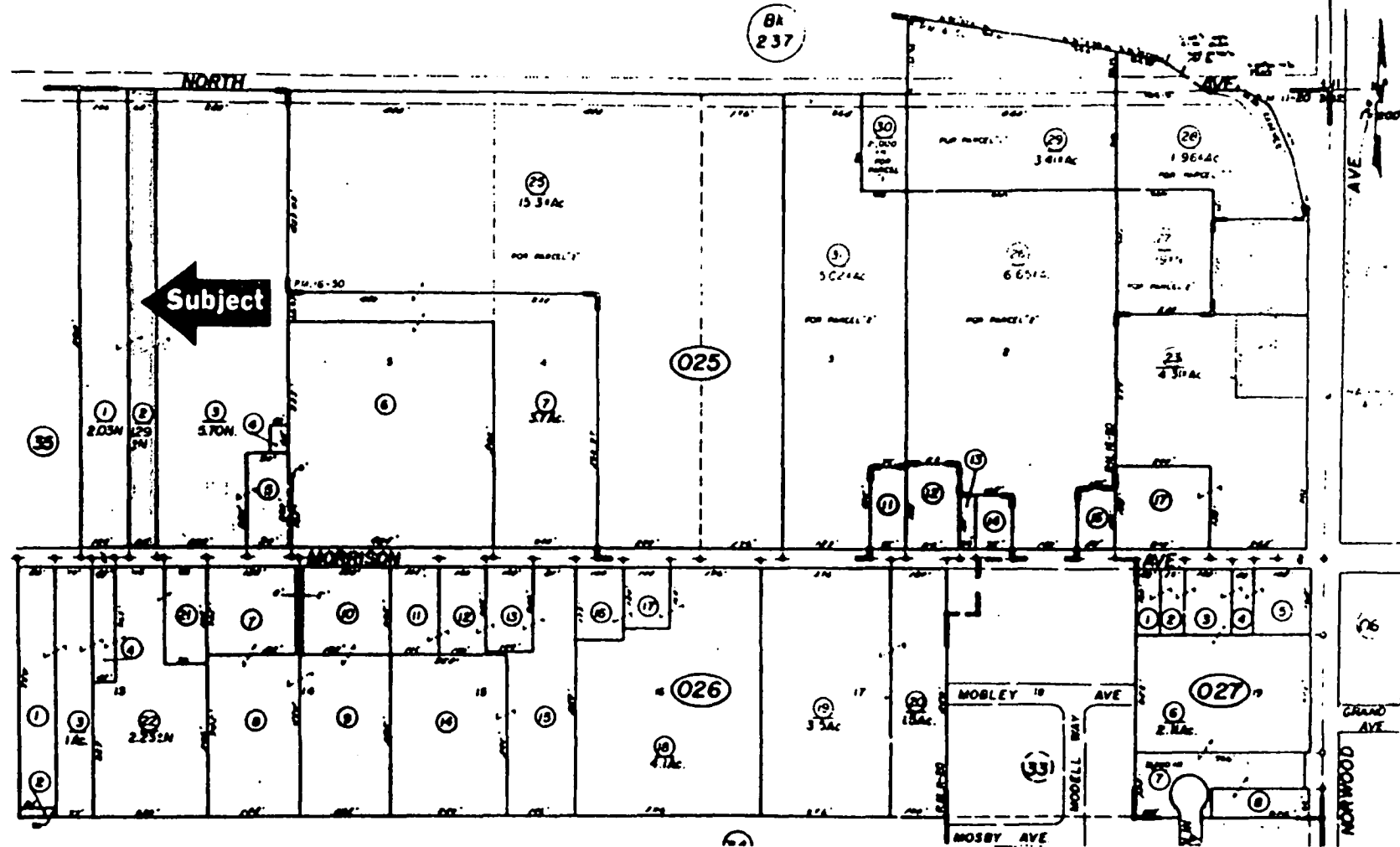
