SUMMARY

The attached resolution amends Resolution 87-224, which specifies employees within the Department of Planning and Development, Nuisance Abatement Division, be granted citation and arrest authority pursuant to Ordinance 85-033. Adoption of the resolution is necessary due to personnel changes.

BACKGROUND

Prior to passage of Ordinance 85-033, certain City employees were designated "Special Police Officers" by the City Manager in order to grant them citation and arrest authority. Classifications within the Nuisance Abatement Division were included in the "Special Police Officer" designation. Due to confusion, which arose between the "Special Police Officer" and Peace Officer status under the Penal Code, Ordinance 85-033 was adopted to change the way citation and arrest authority was granted.

The ordinance eliminated "Special Police Officer" status and specified that the City Manager submit to the City Council a list of persons within the classification to be granted citation and arrest authority. The Council would grant the authority by resolution.

FISCAL DATA


The granting of citation and arrest authority has no fiscal impact.

RESOLUTION AMENDING RESOLUTION
NO. 87-224 GRANTING CITATION
AND ARREST AUTHORITY TO CERTAIN
EMPLOYEES

WHEREAS, the City Council adopted Ordinance 85-033 on April 23, 1986; and

WHEREAS, said Ordinance requires that a list of employees occupying job classifications designated for arrest and citation authority be submitted to the City Council; and
