Village Street Lighting Assessment District,

BACKGROUND INFORMATION

On May 13th, 1980, the City Council approved plans and specifications for Brentwood Village and Freeport Village Street Lighting Assessment District and bids were received and opened by the City Clerk in the Council Chambers on June 24th, 1980. Bids received are as follows:

\$102,732.00 May-Han Electric Inc., dba M & M Electric \$126,126.00 Grason Electric Company \$164,991.00 Smith Electric Supply

The low bid of May-Han Electric Inc. dba M & M Electric, in the amount of \$102,732.00, is 7.4% below the Engineer's Estimate of \$110,950.00.

FINANCIAL DATA

This project is to be financed jointly by the property owners within the District and the City of Sacramento. The City's portion of the cost is estimated to be \$6,422.00 and is to be funded from Gas Tax Fund, 2-02-2600-8990-4820.

RECOMMENDATION

The City Engineer recommends that the low bid of May-Han Electric Inc., dba M & M Electric, in the amount of \$102,732.00, be accepted.
