Based on documentary and oral evidence submitted at the public hearings on September 23, 1980, and November 12, 1980, the City Council approved the Variance to permit a dock with a dimension of four feet by sixty-one feet (244 square feet) subject to the following findings:

- The granting of the Variance is not a special privilege in that the applicant is replacing an old boat dock and is not increasing the capacity of present facility.
- 2. The Variance request is not a use Variance in that the boat dock is a non-conforming use.
- 3. The proposal is not injurious to the public welfare in that the boat dock will not significantly change the characteristics of the river.
- 4. The proposal is not contrary to the Sacramento River Parkway Plan in that the proposed dock is similar in square footage and capacity. The facility will not be expanded to allow additional boats.

On November 12, 1980, the City Council indicated an intent to deny the Variance request based on findings of fact due November 25, 1980.

Based on documentary and oral evidence submitted at the public hearings on September 23, 1980 and November 12, 1980, the City Council denied the Variance subject to the following findings:

- 1. The variance is not consistent with the policies and goals of the Sacramento River Parkway Master Plan which discourages expansion of private boat docks.
- 2. The granting of a variance would set a precedent for similar requests.

The City Council, however, permitted the applicant to retain a dock with a dimension of four feet by sixty-one feet (244 square feet).
