SUBJECT: Quitclaim Deed to be Executed by the City to North Sacramento Land Company (Commerce Circle and Lathrop Way).

SUMMARY

Adoption of a Resolution authorizing the execution of a quitclaim deed to North Sacramento Land Company to clear a cloud from their title.

BACKGROUND INFORMATION

North Sacramento Land Company is about to develop their property adjacent to the American River and at the end of Lathrop Way. Upon issuance of a preliminary title report from Western Title Company, it was discovered that the City of Sacramento may be successors in title to rights owned by the now dissolved North Sacramento Light and Water Company to an unknown interest in the property to be developed.

To clear up the cloud created by a deed to North Sacramento Light and Water Company, recorded February 10th, 1912, will require the City's execution of a quitclaim deed to North Sacramento Land Company. The Real Estate Division has reviewed the various deeds and documents submitted by Western Title Company and find that we are not giving up any rights that the City may have in this area.





RESOLUTION NO. 80-654

Adopted by The Sacramento City Council on date of

AUTHORIZING CITY MANAGER AND CITY CLERK TO
EXECUTE QUIT CLAIM DEED TO NORTH SACRAMENTO
LAND COMPANY.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:

That the City Manager and City Clerk be authorized and directed to execute a quitclaim deed to North Sacramento Land Company in order to remove a cloud on their title to the following described property:

All that real property situate in the State of California, County of Sacramento, City of Sacramento, described as follows: All that portion of Sections 1 and 69 of Rancho Del Paso, according to the official plat thereof, filed in the office of the Recorder of Sacramento County, California, on March 4, 1911, in Book A of Surveys, Map No. 94, lying North of the North line of the property described in the deed from North Sacramento Land Co., a corporation, to American River Flood Control District, dated September 6, 1932, recorded September 8, 1932, in Book 408 of Official Records, page 108; South of the South line of the property described in the deed from North Sacramento Land Company, a corporation, to Central Pacific Railway Company, a corporation, and the Western Pacific Railroad Company, a corporation, dated March 24, 1958, recorded April 11, 1958, in Book 3489 of Official Records, page 253, and re-recorded on August 15, 1958, in Book 3568 of Official Records, page 628; and on the East by the West line of the property described in the deed from North Sacramento Land Co., a corporation, to American River Flood Control District, dated July 29, 1957, recorded January 9, 1958, in Book 3431 of Official Records, page 256.

EXCEPTING THEREFROM:

Beginning at a point from which the Northeast corner of Section 69 bears North 01° 15' 20" West 74.96 feet and North 89° 02' 30" East 2716.86 feet; thence from said point of beginning South 01° 15' 20" East 80.00 feet; thence curving to the right on an arc of 439.89 feet radius, said arc being subtended by a chord bearing North 79° 41' 40" West 183.93 feet; thence curving to the right on an arc of 849.37 feet radius, said arc being subtended by a chord bearing North 42° 47' 10" West 55.06 feet; thence North 88° 14' 10" East 216.71 feet to the point of beginning, as described in the deed from North Sacramento Land Co., a corporation, to the City of North Sacramento, a municipal corporation, dated July 6, 1953, recorded September 8, 1953, in Book 2472 of Official Records, page 572.
