
RECOMMENDATION:

This report recommends that the City Council adopt the attached resolution which authorizes the following:

- Approve a Cooperative Agreement concerning project management, construction and cost sharing with Caltrans.
- Appropriate \$30,000 in Caltrans funds for this project.
- Approve the plans and specifications for the Freeport Boulevard and Florin Road Traffic Signal Modification (PN:TG66) project.
- Authorize the City Clerk to advertise for bids to be received on December 29, 1993.

SUMMARY:

This project involves the modification of an existing traffic signal at the intersection of Florin Road and Freeport Boulevard. The modifications include street reconstruction and widening, construction of a handicap ramp, installation of a fire alarm pre-emption for emergency vehicle traffic along Freeport Boulevard and construction of miscellaneous curb, gutter, and sidewalk.

This report recommends that a Cooperative Agreement with Caltrans be approved which describes the State/City cost sharing and project management and construction responsibilities for this project. It also recommends that \$30,000 in Caltrans funds be appropriated to the project towards construction and contract administration.

Plans and specifications for the Freeport Boulevard and Florin Road Traffic Signal Modification (PN:TG66) project have been prepared. Approval of the plans and specifications and authorization to advertise for bids is recommended.

COMMITTEE/COMMISSION ACTION:

BACKGROUND INFORMATION:

This project involves the modification of an existing traffic signal at the intersection of Florin Road and Freeport Boulevard. The modifications include street reconstruction and widening, slurry sealing of the street, regrading ditch embankments, construction of a handicap ramp; installation of a fire alarm preemption for emergency vehicle traffic along Freeport Boulevard; and construction of miscellaneous curb, gutter, and sidewalk.

The modifications include adding a dual left turn pocket to facilitate the movement of traffic from south to east through this intersection, which will alleviate traffic congestion.

Under a cooperative agreement with Caltrans, the state will pay \$30,000 towards the construction and contract administration of the project.

A Categorical Exemption for the Freeport Boulevard and Florin Road Traffic Signal Modification (PN:TG66) project was filed with the County Recorder of the County of Sacramento on September 6, 1991. Estimated completion date for the project is July 29, 1994.

FINANCIAL CONSIDERATIONS:

The engineer's estimated construction cost is \$113,000.

The estimated total project cost, including all planning, design and construction costs, is \$188,000. The project budget with the additional Caltrans contribution totals \$130,000 in Transportation Sales Tax and State Capital Grant funds.

Additional funds may be required to provide for contract inspection, administration and construction contingencies. Recommendations for additional funding will be made after receipt of bids, if required.

A non-refundable fee of \$25.00 will be charged for each set of plans and specifications to cover reproduction costs.

POLICY CONSIDERATIONS:

This action is consistent with Title 58, Chapter 58.03.301 of the City Code concerning advertisement for bids and Resolution No. 93-149 relating to MBE/WBE participation goals and policies adopted by the City Council on March 30, 1993, and existing City policy concerning cooperative agreements for capital improvement projects.

MBE/WBE:

This project will include MBE/WBE participation goals of 10.57% MBE and 9.5% WBE as required by Resolution No. 93-149 relating to MBE/WBE participation goals and policies adopted by the City Council on March 30, 1993. Award of contract will be contingent upon the responsive low bidder either meeting this project MBE/WBE participation goals or making adequate Good Faith Efforts towards meeting the project goals.

Plans and specifications will be sent to seven (7) plan rooms and construction services organizations for publication and use by the construction industry of Northern California. There are four (4) organizations on the distribution list that are directly involved with outreach to MBE/WBE contractors.


