### SUMMARY

The Division of Water and Sewers has received bids for the subject project and recommends that a contract be awarded to the low bidder, Tatum & Sons.

### BACKGROUND

The water mains which serve this area were installed in the 1940's and were made of thin-wall steel, which corrodes with time. During the last several years it has been necessary for City maintenance personnel to make an excessive number of repairs to these badly deteriorated mains. On March 30, the Council adopted plans and specifications for the subject project. Bids were received on April 20, 1982.

The engineer's construction estimate was \$82,000.00 for this project. The low bid of Tatum & Sons consisting of \$80,799.77 is \$1,200.23 below the Engineer's estimate.
